The Mayor and Councillor Kovac, along with the City Clerk, presented to Mrs. Udashkin a commemorative plaque as well as a bouquet of flowers for her thirty years of dedicated service as a City of Côte Saint-Luc volunteer. A reception was held for friends and family following the presentation.

RECREATION – PARTNERSHIP WITH THE HEART AND STROKE FOUNDATION TO IMPLEMENT THE *HEART IN MOTION* PROJECT WITHIN THE CITY

WHEREAS the City of Côte Saint-Luc and the Canadian Heart and Stroke Foundation wish to enter into a partnership agreement ("Agreement") to implement the *Heart in Motion* project within the City of Côte Saint-Luc;

WHEREAS the *Heart in Motion* project creates a network of walking paths throughout the City clearly identified with directional signs for pedestrians as well as signs estimating the distance walked;

QUESTION PERIOD

The question period started at 8:35 p.m. and finished at 9:05 p.m. Six (6) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident registered his disappointment regarding the poor attendance at the hearings of the transport commission which discussed the Cavendish Extension. Mayor Housefather explained to the resident that attendance was not the key measurement of the success of the hearings as there were indeed many other successful initiatives taken by Côte Saint-Luc regarding these hearings. Some of these initiatives, he explained, included the presentation of cogent briefs in support of extending Cavendish and convincing other municipalities and boroughs such as: Hampstead, Montreal West, Dorval, Dollard-Des-Ormeaux and Côte des Neiges – Notre Dame de Grâce to adopt similar resolutions to the one adopted by Côte Saint-Luc supporting the Cavendish Extension.

The resident then complained that many bicycle riders do not wear helmets and consequently, should be issued notices of infraction to which Mayor Housefather responded that the Commander of Police Station 9 is in attendance tonight and has taken note of the resident's comments.

2) Harry Oberman

The resident wished to thank the Mayor, Council and the City Clerk for the professional manner in which the Register was held at Le Vicomte on August 22, 2007.

The resident then requested that the City look into a traffic problem at the area of Abraham De Sola next to Le Vicomte by trying to remedy it by making it a one-way traveling East to West as well as prohibiting right hand turns from 7:00 a.m. to 10:00 a.m. to which council took note.

3) Irving Itman

The resident inquired as to whether the entire council was unanimous in supporting an additional extension out of Côte Saint-Luc to which Mayor Housefather responded in the affirmative. The resident then requested that Côte Saint-Luc ensure that the Cavendish Extension be realized to which Mayor Housefather responded that the City is doing all it can in its power to ensure that Cavendish is extended within the soonest possible delay.

The resident then inquired as to whether benches on Kildare have been removed to which Councillor Kovac responded that – to her knowledge – the only benches which were removed were done so for repair and would be replaced.

4) Steven Abrahms

The resident approached the microphone with his fellow neighbour and went on record as speaking for both himself and his neighbour. He then called for traffic-calming measures on Pinedale Avenue – between Merton Road and Fleet Road – to which Mayor Housefather reassured him that Councillor Berku is taking initiative to ensure that a solution would be found promptly. The resident then went on record as requesting that a traffic-calming measure be placed in front of his home.

5) Linda Mahler

The resident recounted an incident wherein someone was giving her and her daughter a lift and the parked car, the car in which she and her daughter were in, according to her account, was hit by a recycling truck. The resident opined that the driver of the recycling truck didn't see the vehicle and her daughter could have been killed by the accident. Mayor Housefather then requested the resident remit all of the salient details to the City Clerk so that the recycling company and/or its insurer can be put on notice regarding the incident.

The resident then inquired as to how many individuals must be in the recycling truck while on shift to which Mayor Housefather responded that the City Clerk will procure the legal information requested.

6) Jack Cabot

The resident explained that too many individuals are not respecting the rules regarding Stop Signs to which Mayor Housefather responded that the Commander of Police Station 9 is in the audience tonight and has taken note of the resident's comments.

The resident then registered his view that the Cavendish Extension should be given priority over *obsolete transportation*.
