QUESTION PERIOD

The question period started at 8:00 p.m. and finished at 8:45 p.m. Six (6) people asked to speak and they were heard.

1) Avrum Shtern

The resident recounted that the Vice President of Group Pacific doesn't believe in litigation (despite her company being plaintiff in a case against the City of Côte Saint-Luc) to which Mayor Housefather responded that since she didn't favour litigation, she should hopefully withdraw her current one against the City as the City is of the strong opinion that it is entirely baseless.

The resident then explained that when he addressed the issue of Meadowbrook with Claude Dauphin, Mayor of Lachine, he was told by Mayor Dauphin that he would first see representatives of Côte Saint-Luc and Montreal West to which Mayor Housefather responded that Mayor Dauphin should indeed consult with Côte Saint-Luc and Montreal West before entertaining any ideas regarding the development of the Borough of Lachine's portion of Meadowbrook territory.

The resident then apprised council that there was a successful town hall meeting held in Montreal West regarding Meadowbrook and was wondering whether Côte Saint-Luc would consider hosting a similar meeting to which Mayor Housefather responded that council would entertain the idea.

2) Dr. Bernard Tonchin

The resident recounted that he recently returned from a two week trip to Israel and specifically visited Côte Saint-Luc's twin City of Ashkelon. He advised council that he met with both the Mayor and the Deputy Mayor of Ashkelon and presented

certain items which the City of Ashkelon wished to give to the City of Côte Saint-Luc.

3) Ruth Benor

The resident expressed difficulties regarding her ability for her and others in her family to enter and egress her property due to all of the snow in front of it subsequent to the most recent snow storm. She then explained that her house is susceptible to flooding and called upon the City to be sensitive to this issue. Mayor Housefather explained to the resident that the City went above and beyond what it could in terms of snow removal during the most recent storm and insofar as her immovable's sensitivity to flooding is concerned, the City could look into what, if anything, it could do to assist her in avoiding future flooding.

4) Marcia Ackerman

The resident went on record as opposing fluoridation of water to which Mayor Housefather clarified that Côte Saint-Luc receives its water from the City of Montreal and the City of Côte Saint-Luc could only *recommend* to the City of Montreal what type of water it would receive. He then explained that council is presently studying the various materials and would issue a recommendation to the City of Montreal once it has reviewed the evidence.

The resident then complained that her building still does not have recycling to which Mayor Housefather explained that by the end of 2009, he was hopeful that the city would be able to deliver recycling to all of the city's buildings.

The resident then opined that pigeons do not transmit diseases to humans and requested that the city 'leave the birds alone' to which all members of council took note.

5) Gerald King

The resident inquired as to whether it was legally necessary for his immovable to have a generator to which Mayor Housefather responded that the City Clerk could get back to him with an answer.

6) Mrs. Elise King

The resident apprised council that it is difficult to be able to properly cross the street at the intersection of Westminster Avenue and Côte Saint-Luc Road and requested that City explore avenues to make the crossing at that intersection safer to which all members of council took note.

SECOND QUESTION PERIOD

The Second question period started at 9:38 p.m. and finished at 9:52 p.m. Three (3) people asked to speak and they were heard.

1) Alex Davis

The resident wished to congratulate the City on its effective snow removal operations.

The resident inquired as to why certain Site Plan approvals were deferred tonight to which Mayor Housefather responded that the City's Planning Advisory Committee is presently working with the requesters to see if they can come up with a mutually satisfactory design.

The resident referred to a development project on Robert Burns and then requested that the City of Côte Saint-Luc not adopt non-expedient by-laws such as those adopted by the City of Montreal to which all members of council took note.

2) <u>Dr. Bernard Tonchin</u>

The resident commented that on the whole, the City is doing a good job regarding its snow removal operations but stated that at 2:30 this afternoon, he had difficulties exiting his driveway and had to shovel the snow to clear an aggress path. He then made certain suggestions regarding snow removal operations to which Councillor Brownstein responded that since the Director of Public Works is presently in the audience, he can take note of the suggestions and implement them if he deems them viable.

3) <u>Avrum Shtern</u>

The resident opined that for the removal of sidewalks it's 'hit and miss' to which Councillor Levine responded that the City is presently implementing a procedure of first removing snow on sidewalks on alternate sides of the street so that each street has at least one side cleared expeditiously prior to both sides being cleared.

The resident made reference to Councillor Berku's resolution concerning the railway tax and opined that while the environmental impact of railways may be pernicious (i.e. nuisance regarding to noise and vibrations), it is important to compare the alternative. He explained that it is important to keep in mind that railways are very energy-efficient and not as polluting as trucks and since highways have been nationalized for over 100 years, it is important to *level the playing field* to which all members of council took note of his comments.
