EXPRESSION OF CONDOLENCES - FALLEN CANADIAN SOLDIER IN AFGHANISTAN

WHEREAS the Canadian Armed Forces have been called up to serve in Afghanistan in an effort to help restore order and protect the peace as part of a multi-national force; and

WHEREAS the brave soldiers of the Canadian Armed Forces are often in harm's way in service to Canada and all Canadians;

QUESTION PERIOD

The question period started at 8:00 p.m. and finished at 9:00 p.m. Seven (7) people asked to speak and they were heard.

1. Karen Gerstein

The resident complained regarding the construction at 6521 Merton road as she opined that the owner has languished in completing the process and requested that the house be expeditiously completed.

Mayor Housefather explained to the resident that from the point of view of council, the matter is unacceptable and council has done its best to ensure construction is properly completed in a timely manner. Mayor Housefather then expressed council's openness to receiving feedback from the residents regarding whether or not they wish to see the exemption granted tonight.

2. <u>Dr. Bernard Tonchin</u>

The resident opined that members of the public who are present tonight to issue comments regarding the immovable located at 6521 Merton should remain until the end of the meeting so that they may ask further questions or issue further comments during the second question period.

The resident then inquired as to what was occurring with the City's composting program to which Councillor Erdelyi responded that on May 25th, the City will be holding an ECO-Action Committee event in which free composting will be given out and the City will be having speakers such as M.N.A. Lawrence Bergman and Professor Joe Schwartcz.

The resident inquired as to when the City will be painting lines on its roads to which Mayor Housefather responded that the City went out to tender early for the contract but did not receive any eligible bids and would be going out to tender again to receive bids so that it may start the process in a timely manner.

3. Toby Benlolo

The resident advised council that she sent the City a letter regarding a trafficcalming request and solicited feedback from council to which Mayor Housefather responded that he could not comment on the request since he has not seen the letter but that the Traffic Committee would examine her request and someone from the City would respond to her in a timely manner.

4. Mortie Braunstein

The resident opined that the purpose of the door to the garage which was the object of a minor exemption request for the immovable situated at 6521 Merton was dubious.

The resident then complained regarding the construction site at 6521 Merton to which Mayor Housefather responded that potentially, by granting the exemption tonight, the house would be built in a timelier manner which would ultimately alleviate the nuisance of the construction site.

The resident then complained that McDowell Park requires work and is presently messy to which Mayor Housefather responded that the City could look into this.

The resident then complained that motorists were speeding on Randall to which Mayor Housefather responded that the City took proactive measures to install

traffic-calming measures on Randall and has done all it could do to alleviate speeding on this street.

5. Hershey Fellig

The resident claimed that he is speaking on behalf of his wife (who is the property owner) and requested that the request for a Minor Exemption on tonight's agenda not be granted until his immediate neighbour resolves his outstanding issues with him and his wife. He requested that the City, 'not give an inch' until his neighbour shows good faith. He further called upon the City to compel the owner of 6521 Merton to respect City by-laws.

Mayor Housefather then reassured the resident that the City will expend all possible efforts to assist this resident in resolving outstanding problems with his neighbours but considering there are civil matters beyond the purview of the City's jurisdiction, not all issues can be resolved by the City.

6. Eric Berman

The resident opined that he does not want the minor exemption request for 6521 Merton to be granted tonight as it would be *giving up an inch of his neighbourhood*. He then called upon the owner of 6521 Merton to enact restaurations to his property which has, according to him, been directly affected by the construction. He also called upon the owner of 6521 Merton to issue him restitution.

7. Daniel Hazan

The resident advised council that it is his home which forms the object of tonight's minor exemption request and opined that the inch he is requesting is negligible. He further explained that he is baffled by tonight's reaction from his fellow neighbours as he had previously thought that they were his friends and supported his request. He then explained to council that while his immediate neighbour complained that he dumped dirt on his land, his immediate neighbour requested that the dirt be dumped but that his neighbour's wife was not happy with the dumping of the dirt hence the conflict today. He then explained to council that all he wants to do is build his home and that, in his view, his fellow neighbours are using the City as a weapon to get the City to resolve their civil matters with him.

Mayor Housefather then inquired as to whether the resident would be willing to sit down with his neighbours to try to resolve his outstanding issues with them to which the resident responded in the affirmative. Mayor Housefather then added that the City, on a best efforts basis, could agree to mediate the process and would attempt to set up a meeting sometime this week.

Councillor Berku then went on record as stating the City is responsible to maintain peaceable enjoyment of existing residents and to minimize the negative impact of new construction. Whereas the new construction at Randall and Merton has created drainage problems for the neighbours downhill on Borden and Randall the City should ensure that these problems are corrected.

Councillor Levine then went on record as requesting that the resident withdraw his request for a Minor Exemption concerning the door adjacent to his garage since the purpose for which it was initially intended is no longer required.
