QUESTION PERIOD

The question period started at 8:15 p.m. and finished at 8:45 p.m. Four (4) people asked to speak and they were heard.

1) Pierre Cohen

The resident informed the Council that the current situation that he is faced with involving damages to his house as a result of works completed by the City cannot last. He inquired as to what the City is prepared to do to correct the problems that he is facing.

Mayor Housefather responded that the file involving the resident's property is in litigation as the result of the resident and he therefore cannot give any explanations or answers. He stated that he has written to the resident to state that there is no negligence on the part of the City of Côte Saint-Luc. He further commented that at this point, the person to whom the resident must address his questions to regarding the matter is the City's lawyer.

2) Ronald Caigne

The resident stated that he is a duplex owner and he inquired why he has to pay for his recycling bin as well as the recycling bin of his tenant. He asked that in light of the substantial tax base that the City has is it necessary to down load on duplex owners to purchase the blue bins for the recycling program.

Mayor Housefather stated that the City decided that instead of incorporating the amount of the bin into the tax base and have an inflated amount to taxes in the following years, Council decided to have a one time payment for the blue bins in order to be transparent.

The resident also asked who is responsible for taking out the tenant's blue bin out to which Mayor Housefather stated that the tenant is responsible for own bin.

3) Dr. Bernard Tonchin

The resident stated that he feels that residents are still not complying with the bylaws regarding garbage in that they are putting out the garbage too early and it looks terrible and it attracts rodents and birds.

Mayor Housefather informed the resident that the Council has recently amended the by-law to include that the garbage bags must be must be placed in a container with a sealed lid. He further stated that the residents are being warned that if they do not adhere to the by-law, they will be fined.

The resident requested information regarding the parking allowances during the holidays to which Mayor Housefather replied that all parking information is available on the City of Côte Saint-Luc web-site.

4) Murray Levine

The resident read a letter regarding the Municipal involvement of cities around the island for the La Tour de l'Ile. He stated that the City of Côte Saint-Luc has been very generous in their charitable contributions over the years but the decision to not allow entry into Côte Saint-Luc for the Tour was very disappointing. He stated that he is aware that the City does not want to inconvenience its residents. His question is if the City of Côte Saint-Luc is prepared to reopen the matter to allow La Tour de l'Ile entry into Côte Saint-Luc.

Mayor Housefather stated that he congratulates the resident on all the work that he has done for charity but he could not at this point invite the tour back because after investigation the Council felt that it would cause inordinate traffic issues. He further stated that although this was not possible at this time, the Council will continue to monitor the situation.
