The resident explained to council that as a representative of Hebrew Academy (High School) she recently requested that a fence be erected adjacent to the school to which Mayor Housefather responded that the matter was referred to the Parks and Recreation Committee and the City would return to her with an answer.

4) <u>Marjorie Black</u>

The resident complained of a recent change in *no-parking* restrictions on Trinity to which Mayor Housefather responded that the matter would be taken under advisement and if any signs have been misdirected they would be put back up.

The resident complained of an overly powerful p.a. system used for the Côte Saint-Luc municipal swimming pool to which Mayor Housefather responded that the City can look into the matter to see if anything can be done.

5) Rachel Genziak

The resident inquired as to where Hampstead building permits were kept which were issued during the time that Hampstead was part of the borough to which Mayor Housefather responded that they are presently archived in Hampstead.
