MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, JUNE 8, 2009, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

PRESENT:

MOMENT OF SILENCE IN MEMORY OF SHEILA FINESTONE FORMER M.P. FOR MOUNT ROYAL

A moment of silence was held in honour of Sheila Finestone, former Mount Royal M.P. and Senator, who unfortunately passed away today.

QUESTION PERIOD

The question period started at 8:05 p.m. and finished at 8:38 p.m. Seven (7) people asked to speak and they were heard.

1) Henry Gitelman

The resident complained regarding the state of Cavendish Boulevard – near Mackle and Collins. Mayor Housefather explained to the resident that this summer, the area in question will be resurfaced. He then further clarified that until recently, the area on Cavendish Boulevard to which the resident refers was considered an arterial road thus formerly rendering it the responsibility of the Agglomeration. Therefore, he further explained, the road could not have been resurfaced any sooner by the City of Côte Saint-Luc as it only recently reacquired the jurisdiction to resurface arterial roads on its territory.

2) Avrom Shtern

The resident congratulated the City of Côte Saint-Luc for its position regarding Meadowbrook and particularly congratulated Mayor Housefather as well as (Montreal West) Mayor Campbell Stuart for their support of Meadowbrook as an eco-territory. The resident then inquired with Mayor Housefather as to how he intends to vote regarding Meadowbrook when the matter shall be tabled for adjudication to which Mayor Housefather responded that he intends to vote in favour of its protection (as an eco-territory). The resident then went on record stating that without the work of (the late) Jack Cabot, the foregoing could not have been accomplished.

3) Peter Benisti

The resident called for traffic-calming measures near Heywood and Kellert as well as the reduction in the speed limit at that area to which Mayor Housefather responded that the Traffic Committee could study his request regarding traffic-calming measures and someone in the City would return to him with an answer. He then added that an amendment to provincial legislation is pending which would reduce the default speed limit from 50 km/h to 40 km/h and that in conjunction with this, the City intends to reduce its default speed limit on the vast majority of its streets to 40 km/h.

4) Naomi Balardelle

The resident advised council of her letter of refusal from the Planning Advisory Committee regarding her choice of bricks on her immovable as well as the obligation to submit a plan and asked that when council adjudicates upon her Site Plan, that they dispense her from submitting a plan regarding the bricks and accept her choice of bricks. Mayor Housefather explained to the resident that council relies on the recommendation of the Planning Advisory Committee to render its decisions regarding these technical matters. Therefore, should she wish to discuss the matter further, she should see the City's Urban Planning Manager (in the audience tonight) after question period.

5) Jerry Weiss

The resident inquired as to what is being done in Côte Saint-Luc to avoid what occurred in the City of Montreal where there were accusations of bias towards one tenderer for the awarding of a contract concerning water meters. Mayor Housefather explained to the resident that this council is bound by provincial legislation which forbids each of its members from having, for example, a pecuniary interest in any contract. To this end, the law obliges each member of council to disclose their pecuniary interests (i.e. in a city contract) and not vote on a contract in which they have such an interest. He also explained that there are laws contained within the Criminal Code which forbid councillors from taking bribes. He then explained that there is no executive committee in Côte Saint-Luc (which meets in private) and the City Council meetings are held in public and not behind closed doors which makes for greater transparency.

6) Leo Sculnik

The resident inquired as to what the status of his request from last month concerning a mature City tree causing him and his family hardship to which Director Tordjman responded that the City looked into it and that the tree was healthy so it will not be felled. Director Tordjman then stated that the City is looking into slightly pruning the tree but would not prune it significantly.

7) Carmen Romero ¹

The resident advised council that her backyard, along with her fellow residents on Hudson, are adjacent to Adar Bakery. She then stated that on Tuesday, April 28, at 7:45 in the forenoon, she watched, in horror, as a Lexus crashed through fences and landed in a resident's backyard. She then explained that she, along with her fellow neighbours are fearful to go into their backyards. She then stated that, although she contacted the City, she has yet to receive a status report on her request for redress so that the same accident would not reoccur. She also requested that the City convene a meeting with Adar and have representatives from both the City and Adar present at the said meeting so issues may be

discussed and solutions may be had so that she, and her fellow residents feel that their safety is indeed insured. She also tabled several photos of the incident.
