QUESTION PERIOD

The question period started at 8:10 p.m. and finished at 8:45 p.m. Three (3) people asked to speak and they were heard.

1) Gabrielle Artzi

The resident complained that the waiting time for the traffic lights on Mackle and Cavendish is extremely long and called upon the City to install roundabouts in that area to alleviate any traffic issues to which Mayor Housefather responded that the City already looked into this suggestion and did not find it practical to install them in that area in particular, because they are not installed island-wide so drivers would have issues getting used to them and because with Cavendish eventually extended they would not dovetail well with the rest of the new corresponding traffic configuration. Mayor Housefather then explained that the City is nonetheless looking into innovative traffic solutions on Cavendish Boulevard such as having cars turn right at Cavendish onto Mackle in an even more efficient manner. It is also looking into having shorter blocks where pedestrians have more opportunity to cross the street (similar to Israel).

THE CITY CLERK LEFT THE MEETING AND THE ASSISTANT CITY CLERK BECAME THE SECRETARY

2) Dr. Bernard Tonchin

The resident called upon the City to exert pressure on Mayor Tremblay to preserve Meadowbrook as a greenspace as well as to exert pressure on all three levels of government to assist Côte Saint-Luc in realizing its objective to extend Cavendish. Mayor Housefather reassured the resident that Côte Saint-Luc is doing all it can on both issues and is at the forefront on both of them. He further explained how he, along with Councillor Berku, have both made representations on the City's behalf regarding both aforementioned issues. He added that he, along with Councillor Berku, met with M.N.A. Bergman as recently as Canada Day on the issue of the Cavendish Extension. He then explained that the City has reported on both issues in its publication materials and on its website. Mayor Housefather then clarified for the resident that Côte Saint-Luc experienced many successes on both fronts including recommending Meadowbrook to be added to the list of Agglomeration eco-territories and having the Cavendish Extension moved up on the Transport Plan from 2017 to 2012. He further clarified that the City will continue to be at the forefront and be proactive both regarding Meadowbrook and the Cavendish Extension.

The resident then called upon the media to report on both issues as he opined both issues' successes are tantamount to Côte Saint-Luc.

3) Steve Avram

The resident expressed concern over bins being too many colours and sizes as well as being replete throughout the City because they are not removed on collection days. He then alleged that residents are unaware as to what to do with each bin.

Mayor Housefather explained to the resident that the City has sent out numerous publications on what do to for each bin well as a letter to each household in Côte Saint-Luc requesting they advise the City as to which size bin they elect. He further explained that the City has volunteers issuing courtesy tickets for those leaving their bins outside of collection hours, what each colour bin represents as well as having said volunteers clarifying for those residents as to when collection hours are for each bin. He then advised the resident that Côte Saint-Luc must divert a portion of its waste failing which they will lose subsidies and in addition, receive fines from the Provincial Government.
