RESOLUTION TO ESTABLISH THE STANCE OF THE CITY OF CÔTE SAINT-LUC COUNCIL ON ISSUES TO BE PRESENTED AT THE MONTREAL URBAN AGGLOMERATION COUNCIL MEETING

WHEREAS according to section 4 of *An Act respecting the exercise of certain municipal powers in certain urban agglomerations* (R.S.Q., c. E-20.001) (hereinafter "the Act"), the urban agglomeration of Montreal is made up *inter alia*, of the City of Côte Saint-Luc since January 1, 2006;

WHEREAS according to section 58 of the Act, every central municipality has an urban agglomeration council, the nature, composition and operating rules of which are set out in an order in council and that this agglomeration council constitutes a deliberative body of the municipality;

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance:

WHEREAS an agglomeration council meeting shall be held in September 2009 for which members of the municipal council shall establish the stance that it wishes to take;

SECOND QUESTION PERIOD

The Second question period started at 8:58 p.m. and finished at 9:11 p.m. Four (4) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident inquired as to whether the City has heard of any reports of unsuccessful sleeving of watermain pipes to which Mayor Housefather responded that he has heard of no such reports for the projects currently being undertaken in Côte Saint-Luc.

The resident then inquired as to whether the City looks into leasing vehicles vs. purchasing them to which Mayor Housefather responded that staff will indeed prepare business cases for such items juxtaposing the advantages and disadvantages of purchasing vs. leasing vehicles so Council may render the most financially advantageous decision.

2) Ronald Cane

The resident inquired as to whether the City could withhold funds from the City of Montreal¹ due to lack of infrastructure work in a neighbouring municipality to which Mayor Housefather responded that it principle, it could not.

The resident inquired as to whether the fee schedule on tonight's agenda concerning the library was pertaining to membership fees to which Mayor Housefather responded that the fee schedule on tonight's agenda pertained to library activities and thus did not pertain to membership fees.

The resident then went on record as requesting that Hampstead Town councillors be fined for (in his view) deliberately blocking traffic on their territory.

The resident then went on record as opining that there were too many one-way streets in the City of Montreal.

3) Marc Cohen

The resident inquired as to what the status was with his request to have the City take proactive measures to alleviate traffic on Glencrest - as he was under the impression that the Traffic Committee had indeed made a recommendation to council and that tonight, council would be adjudicating upon the matter. Mayor Housefather then clarified for the resident that the Traffic Committee has reviewed the matter and once council has been apprised of their recommendation, they will then review said recommendation and render a final decision.

4) Brenda Weinberger

The resident inquired as to what actually occurs once the recycled materials and organic waste materials are picked up and further inquired as to whether it is indeed worthwhile to recycle and compost to which Mayor Housefather responded that the Quebec government requires municipalities to properly divert their waste and therefore cities who do not recycle will be fined and conversely, when cities properly divert their waste, government subsidies are indeed awarded. Councillor Erdelyi then responded that by using recycled materials (i.e. in making cans) far less energy is being expended. He then explained that organic waste transforms into compost and that said compost can then be given back to Côte Saint-Luc residents. He further explained that recycling is done by taking the highest grade materials and then recycling them into lower grade materials citing glossy magazines being transformed into newspaper and newspaper being transformed into toilet paper as being examples.
