EXPRESSION OF CONDOLENCES - FALLEN CANADIAN SOLDIER IN AFGHANISTAN

QUESTION PERIOD

The question period started at approximately 8:10 p.m. and finished at approximately 9:00 p.m. Seven (7) people asked to speak and they were heard.

1) Irving Itman

The resident requested that the City look into fixing the lights on Wavell and Hudson leading down the stairs to Westminster to which Mayor Housefather responded that the City would look into it.

The resident inquired as to what occurs with potential surplus monies from the snow budget for this year as thus far, there has not been an excessive amount of snow which has fallen for which Mayor Housefather clarified that a snow budget is set for a given calendar year and therefore, for 2010, the amounts spent in November and December need to be taken into account as well. He then explained that, assuming there would be a surplus, the City would then have the option of reallocating the monies (for a valid expense) or incurring a surplus.

The resident then congratulated Mayor Housefather, all members of council, MNA Bergman and Senator Seidman on achieving *Ledor Vador* in terms of procuring subsidy monies for an intergenerational centre. He then opined that this was an enormous advance forward.

2) Dr. Bernard Tonchin

The resident went on record as supporting the construction of an indoor swimming pool and inquired as to when and where it would be built and when it would be completed. Mayor Housefather explained to the resident that the City is looking into housing the pool in two locations but its preferred location is on EMSB land for which the City is currently in negotiations to purchase. Mayor Housefather then added that the process has already started and the City would like to see actual construction begin in the fall of this year.

The resident then inquired as to whether the public would be able to view the plans for construction to which Mayor Housefather responded in the affirmative.

The resident enquired as to whether the City would react similar to the Town of Mount Royal concerning its dissatisfaction with the agglomeration for which Mayor Housefather clarified that Côte Saint-Luc did indeed react in the same manner as the Town of Mount Royal (as well as several other demerged cities) by opposing the agglomeration water rates.

The resident opined that the Cavendish Extension will never happen for which Mayor Housefather begged to differ.

3) Paul Devreeze

The questioner advised council that he is a former City of Côte Saint-Luc employee and wishes that Caroline Fissette, a former colleague in the audience tonight, table a letter to council concerning an issue he and all of his former Côte Saint-Luc employees currently working in Montreal hold dear to their hearts which is their pension.

4) Caroline Fisette

The questioner explained to council that she was employed as an Assistant City Clerk for the City of Côte Saint-Luc and is now currently a City of Montreal employee. She then requested that the City of Côte Saint-Luc adopt an agreement with the City of Montreal (similar to other municipalities) allowing her as well as her

fellow colleagues to transfer their pension monies to the City of Montreal. She then requested to table a letter concerning the matter to all members of council and further requested a timely response. Mayor Housefather granted her request to table the letter and stated she would receive a response by the end of March.

5) André Cartier

The resident complained that the City of Côte Saint-Luc sanctioned him for the state of his dwelling which he could not tend to as he had more pressing matters to attend to. Mayor Housefather explained to the resident that the City Clerk could look into the matter and get back to him.

6) Tenant representative

The resident explained to council that he is here on behalf of a group of tenants all of whom live in four (4) buildings in District 2. He stated there were serious grievances that each tenant had to which Mayor Housefather responded that the City could look into the grievances but cautioned him that there may not be anything it can do if they strictly concern Landlord/Tenant relationships.

7) Claudia Amsellag

The resident explained to council that her Landlord illegally entered her dwelling without giving proper notice pursuant to article 1925 of the Quebec Civil Code, that he has not remedied several deficiencies within the building which she requested be remedied and that he has given her limited access to her own dwelling as evidenced by changing the keys to said dwelling without notice. She further explained that an inspector authorized the building owner to dispose of certain items in her dwelling but her Landlord exceeded the order given by the inspector by disposing of the entire contents found within the dwelling. She then sought direction from the City as to what to do. Mayor Housefather explained to the resident that many of the issues raised were Landlord/Tenant-related and while he and his fellow members of council sympathized with the resident, there did not seem like there was anything the City could do based on the fact pattern presented tonight. Nonetheless, he stated, the City Clerk could look into the matter to see what, if anything, the City could do regarding the foregoing matter.

Councillor Brownstein went on record as supporting the by-law and added that the City should not be giving its police officers a needless reason to ticket residents.

Councillor Kovac went on record as supporting the by-law but added that having 40 kilometer an hour speed limits everywhere throughout the City was not a panacea.

Councillor Cohen went on record as concurring with Councillor Kovac.

Councillor Erdelyi opined that given certain streets will now be listed at 50 km/h on main streets, all side streets now needed to have 40 km/h signs.

Councillor Berku explained regarding the issue of CSL Road, West of Westminster and regarding the default sector of 40 kilometers an hour: if a motorist erroneously construes that a 50 km/h zone is indeed a 40 km/h zone, the benefit would be to the motorist as he would be travelling 10 kilometers an hour lower which would not provoke the issuance of a statement of offence.

Councillor Brownstein stated that the City wants the signage to be fair, clear and transparent and the purpose of the by-law is to make the City streets safer.

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance;

WHEREAS agglomeration council meetings shall be held in April 2010 for which members of the municipal council shall establish the stance that it wishes to take;
