DRAFT LEGISLATION RESPECTING ETHICS IN THE MUNICIPAL SECTOR

WHEREAS the City of Côte Saint-Luc understands that the Quebec Government intends to introduce a bill proposing legislation respecting ethics in the municipal sector within the next few weeks;

WHEREAS the press has stated that among the several obligations that the above-mentioned bill would impose upon municipalities is the obligation to adopt a Code of Ethics containing a basic list of improper acts and practices and a system of penalties to be imposed by an ethics commissioner, who would be accountable to the *Commission municipal du Québec*;

WHEREAS Bill 48, the Code of Ethics and Conduct for Members of the National Assembly (Code d'éthique et de déontologie des membres de l'Assemblée nationale), which would establish rules of ethics for members of the National Assembly and cabinet ministers, has yet to be adopted;

WHEREAS municipalities are independent levels of government that have the ability to establish their own ethics guidelines;

MOVED BY COUNCILLOR DIDA BERKU SECONDED BY COUNCILLOR RUTH KOVAC

AND RESOLVED:

"THAT the City of Côte Saint-Luc suggests that the Government of Quebec allow municipalities to establish their own ethics guidelines and suggests setting a target date of December 2010 for municipalities to do so;

THAT the City of Côte Saint-Luc suggests that the Government of Quebec not adopt ethics guidelines applicable to municipalities unless such municipalities fail to do so and furthermore the City of Côte Saint-Luc does not support any proposal which would impose harsher, separate rules for municipal elected officials that don't apply to members of the National Assembly;

THAT a copy of this resolution be submitted to the Minister of Municipal Affairs, Regions and Land Occupancy, the Member of the National Assembly for D'Arcy McGee, to the *Union des municipalités du Québec and to all the municipalities on the island of Montreal.*"
