AUTHORIZATION OF PAYMENT OF INSURANCE PREMIUMS

WHEREAS for the purpose of purchasing group property and liability insurance with a possibility of a group deductible, the City of Côte Saint-Luc ("City") participated with other cities and towns in a joint agreement ("Agreement"). The Comité de transition de l'agglomération de Montréal ("The Transition Committee")

reached this Agreement on May 27, 2005 for and in the name of the Island of Montreal municipalities to be reconstituted and the *Union des municipalités du Québec* ("UMQ") for a three-year period: January 1, 2006 to December 31, 2008;

WHEREAS the "UMQ" was mandated by the Transition Committee to act as the representative of this association known as the *Regroupement des municipalités de l'Île de Montréal* (RMIM) and, as such, the UMQ assumed the responsibilities of advisor and deductible fund manager;

WHEREAS a call for tenders was made by the City's original consultants, Optimum Gestion de risques ("Optimum"), Division de Optimum Actuaires & Conseiller Inc. and by the "UMQ" for the "RMIM";

WHEREAS on December 14, 2005, the Côte Saint-Luc City Council, ("Council"), via resolution number 051217, approved the Agreement reached on May 27, 2005 by the Transition Committee for and in the name of the municipalities to be reconstituted on the Island of Montreal and the "UMQ" for the three-year term beginning on January 1, 2006 and ending on December 31, 2008 for the purpose of purchasing group property insurance with a possibility of a group deductible;

WHEREAS at its Regular Meeting of July 14, 2008 Council adopted a new agreement along with the reconstituted municipalities who were party to the previous Agreement said new agreement adopted for a five year period, from January 1, 2009 to January 1, 2014 and providing coverage from the same insurers:

WHEREAS at its Regular Meeting of October 18, 2010 Council awarded a mandate to René Laporte & Associés, as its general consultant, along with the other members of the reconstituted municipalities from January 1, 2010 to January 1, 2011 renewable each year;

WHEREAS René Laporte & Associés went out for public tender on behalf of the reconstituted cities and received the following results delineated further hereunder;

"THAT Council hereby grants the City's property insurance and civil liability contracts – with their corresponding premiums, deductibles where applicable and corresponding payment - from January 1, 2011 to December 31, 2011 as follows;

THAT Council further authorizes payment in the amount of \$82,954.00, plus applicable taxes (if any) for its share contribution of the \$500,000 civil liability group deductible coverage described above herein;

THAT a Treasurer's certificate attesting to the availability of funds to cover the described expenses for the 2011 fiscal year shall be issued at the beginning of 2011."

ENGINEERING – AWARD A CONTRACT FOR THE MANAGEMENT OF THE LOCAL WATER AND SEWER NETWORKS FOR THE CITY OF COTE SAINT-LUC

WHEREAS the City Côte Saint-Luc ("City") administration issued a public call for tenders for the management of its local waterworks and sewer networks and received one bid (C-38-10);

WHEREAS Simo Management Inc. was the only compliant bidder;

WHEREAS the City wishes to exercise its option to award the contract for a period of two years effective from January 1, 2011 until December 31, 2012;

It was

MOVED BY COUNCILLOR STEVEN ERDELYI SECONDED BY COUNCILLOR ALLAN J. LEVINE

AND RESOLVED:

"THAT Côte Saint-Luc City Council hereby awards the contract for the management of the local waterworks and sewer networks for a period of two years effective January 1, 2011 until December 31, 2012 to Simo Management Inc. for:

- a fixed amount of \$641,000.00 plus applicable taxes per year for basic services;
- an amount not to exceed \$85,000.00 plus applicable taxes per year for professional fee services; and
- an amount not to exceed \$927,000.00 plus applicable taxes per year for fee services;

THAT said awarding of the contract shall be pursuant to the terms set out in City Tender C-38-10 together with SIMO Management Inc.'s bid numbered 10-0070-055 as amended by the first amendment to the contract for the management of local waterworks and sewer systems which is effective December 21, 2010;

THAT a Treasurer's certificate attesting to the availability of funds to cover the described expenses shall be issued at the beginning of the each fiscal year." CARRIED UNANIMOUSLY

Subsequent to the adoption of the resolution Councillor Dida Berku went on record explaining that she voted for the aforementioned resolution on the condition that the City conduct a study and evaluate what if any savings would be had if the City would conduct the management of its water and sewer infrastructure *in-house*.
