# EXPRESSION OF CONDOLENCES - FALLEN CANADIAN SOLDIER IN AFGHANISTAN

#### **QUESTION PERIOD**

The question period started at 8:08 p.m. and finished at 8:22 p.m. Five (5) people asked to speak and they were heard.

### 1) Aubey Laufer

The resident requested a diagonal crosswalk for certain intersections within the City such as Cavendish and Kildare to which Mayor Housefather responded that such a crosswalk would not be expedient at the locations the resident proposed.

The resident then requested that the 161 Bus Stop be moved subsequent to the Cavendish Mall redevelopment to which Mayor Housefather responded that the City has already suggested this to the STM and is awaiting its comments.

### 2) Arieh Perecowicz

The resident tabled before Council a petition (without signatures) before council requesting criminal legislation be modified in view of preventing sexual abuse. He explained that he wishes to present a signed petition to the Parliament of Canada but he needs a requisite amount of signatures and is seeking City premises (such as the library) in order to solicit said signatures. Mayor Housefather explained that City premises may not be an appropriate venue for such a matter but he would consult his colleagues on council.

### 3) Toby Shulman

The resident requested a pedestrian crosswalk from Mackle to the Cavendish Mall to which Mayor Housefather responded that the City already took the matter into consideration and did not find it expedient to have one.

The resident then inquired as to whom she must contact at the City if she seeks information concerning water quality testing to which Mayor Housefather responded it would be the Engineering Department.

The resident then sought particulars regarding a traffic light on Kildare and Cavendish that was temporarily non-functional (but flashing red) to which Mayor Housefather responded that on one occasion the issue was a power failure and on another occasion the issue was a controller that has since been repaired.

The resident then inquired as to what the City is doing to heighten security in light of the recent crimes committed against many religious institutions on Côte Saint-Luc's territory to which Mayor Housefather responded that the Police as well as Public Security have both always been especially vigilant when it comes to such institutions and shall continue to be.

#### 4) Mark Cohen

The resident complained of heavy through traffic on Glencrest to which Mayor Housefather and Councillor Berku both responded that the City reacted positively to the complaint the first time it was instituted by ordering a sign clarifying for motorists that they should be using Cavendish to go Southbound as well as allowing left hand turns off of Fleet Road for longer periods of time both of which redirected motorists off of Glencrest. Councillor Berku then added that residents need to be even further encouraged and educated to take the alternate routes proposed by the City to avoid heavy through traffic on Glencrest.

### 5) Seymour Silverman

The resident advised council that the recycling bin was too cumbersome for him to manipulate to and from the curb given his difficulties being ambulatory to which Mayor Housefather responded that Councillor Erdelyi can look into the matter and get back to the resident.
