2011 SPRING / SUMMER BROCHURE - AWARDING OF A SERVICE CONTRACT FOR PRINTING

WHEREAS the city requires the printing, in February of 2011, of 16,000 brochures describing its Spring and Summer 2011 activities organized by the Parks and Recreation Department;

THAT correlative to the approval of the aforedescribed contract, Council further approves an amount not to exceed \$10,915.00, plus all applicable taxes, plus an additional amount of 5% of the total amount before taxes for contingencies;

THAT Treasurer's Certificate No. TC 11-0036 dated January 20, 2011 has been issued by the City Treasurer, attesting to the availability of funds to cover the described expenses."

AUTHORIZATION TO SELL THREE CITY LOTS TO 4527038 CANADA INC. AS WELL AS TO ACCEPT THE TRANSFER OF TWO LOTS FROM CENTRE COMMERCIAL CAVENDISH SHOPPING CENTRE CO. LTD.¹

WHEREAS 4527038 Canada Inc. along with its representatives and duly authorized mandataries (sometimes collectively referred to as "the Mall") has legally undertaken to build its entire re-development project as approved by the City of Côte Saint-Luc ("City") within a reasonable delay and in a timely manner; and

WHEREAS the Mall has further undertaken to build the re-development project in accordance with City by-laws as well as its Urban Master Plan;

WHEREAS as part of the redevelopment project the Mall has agreed to transfer certain lots to the City and the City has agreed to sell certain lots to the Mall;

It was

MOVED BY COUNCILLOR DIDA BERKU SECONDED BY COUNCILLOR MITCHELL BROWNSTEIN

AND RESOLVED:

"THAT the preamble of this resolution shall form an integral part thereof as if cited hereinafter at length;

THAT the Côte Saint-Luc City Council ("Council") hereby authorizes the sale of City lot numbers 4572295, 4572297 and 4572298, to the purchaser being 4527038 Canada Inc. (acting as "prête nom" and as nominee for "Centre Commercial Cavendish Cie Ltée / Cavendish Shopping Centre Co. Ltd.") for an amount of Two Hundred and Fifteen Thousand Six Hundred and Twenty-Eight Dollars \$215,628.00, plus applicable taxes;

THAT Council further authorizes the City to receive the transfer of lots numbered 4574825 and 4574827 belonging to Centre Commercial Cavendish Cie. Ltée / Cavendish Shopping Centre Co. Ltd. in exchange for one dollar (\$1.00);

THAT Council further authorizes the signature of the Deed of Sale as well the Deed of Transfer (collectively referred to as "the Deeds") the whole as per the terms and conditions of the said Deeds prepared by Notary Sheldon Merling to be executed by a notary of the Mall's choice the whole at the entire expense of the Mall including, but not limited to notarial fees, registration fees and publication fees;

THAT the aforementioned Deeds of Sale be subject to a resolutory clause in favour of the City;

THAT said Deeds shall be annexed to the Minutes as Annex A to avail herein as if quoted hereinafter at length;

THAT Council further authorizes either the Associate General Counsel or the City Treasurer to sign the Deeds to give effect to the foregoing."

- a) he is requesting that Council vote against the transaction;
- b) that the Mayor veto the transaction and;
- c) he is objecting to the transaction.
