MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, FEBRUARY 14, 2011, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

QUESTION PERIOD

The question period started at 8:10 p.m. and finished at 8:40 p.m. Five (5) people asked to speak and they were heard.

1) Oscar Friefield

The resident complained regarding a Statement of Offense that he received for parking in an area reserved for individuals with handicapped permits and then proceeded to plead his defense. Mayor Housefather explained to the resident that a council meeting is not a proper venue to plead his case and that if he feels that he has a valid defense, he must enter a plea of Not Guilty and plead his case in front of a (Municipal Court) judge. He emphasized that City officials will not request that the Statement of Offence be withdrawn and moreover, would not interfere with the judicial process pursuant to his Statement of Offense.

2) Irving Itman

The resident opined that the font on the electronic billboard at the corner of Cavendish and Kildare was too small to which Mayor Housefather clarified that the sign is owned by a private company who determines the size of the font.

The resident then stated that he has been approached by members of the Jewish Orthodox community inquiring as to whether there would be segregated swimming at the Aquatic and Community Centre to which Mayor Housefather responded that this request would not be acceded to unless the group would pay the necessary operational fees for this activity and they would agree to conduct this activity outside of the operating hours of the Aquatic and Community Centre.

The resident inquired as to the reasons each of the two councillors voted against the demolitions adjudicated upon at the Special Council Meeting (held previous to this meeting) to which Mayor Housefather responded that it would be each Councillor who could advise the resident of same.

3) Dr. Bernard Tonchin

The resident opined that there should be upright signs indicating where handicapped parking spots are located to which Mayor Housefather concurred.

The resident then requested a status update as to whether the City would permit public taxi stands on the street to which Mayor Housefather responded the City is still looking into the issue and that it would be in a position to respond to this request in the month of April.

4) Josh Wisbaum

The resident complained regarding a truck that backed up on his street (in the wrong direction) to which Mayor Housefather responded that in the case where a vehicle (*routier*) commits a moving violation, the <u>police</u> should be called with the salient details in order to investigate.

The resident then requested that the City install temporary No Parking signage on his street prior to cleaning it (as they did recently) to which Mayor Housefather responded that if it had been done recently, then (logically) it should proceed in this fashion again.

The resident then inquired as to why his Municipal Evaluation increased more than other comparable properties to which Mayor Housefather responded that the resident's property increased in value more than the other comparable properties.

5) Mike D'Alessandro

The resident explained that he lives on Trinity and requested traffic-calming measures be installed on his street to which Mayor Housefather responded that the City's Traffic Committee can look into the matter and someone from the City could get back to him.

The resident expressed concern regarding a potential parking issue on Trinity due to the construction of the Aquatic and Community Centre to which Mayor Housefather responded that the City is looking into the necessary parking logistics on Trinity taking into consideration that access to the building may not be from Trinity so there would be no specific incentive for users of the Aquatic and Community Centre not to park on Trinity (vs. in the Aquatic and Community Centre parking lot).
