WHEREAS according to section 4 of *An Act respecting the exercise of certain municipal powers in certain urban agglomerations* (R.S.Q., c. E-20.001) (hereinafter "the Act"), the urban agglomeration of Montreal is made up *inter alia*, of the City of Côte Saint-Luc since January 1, 2006;

WHEREAS according to section 58 of the Act, every central municipality has an urban agglomeration council, the nature, composition and operating rules of which are set out in an order in council and that this agglomeration council constitutes a deliberative body of the municipality;

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the Mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the Mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance;

WHEREAS agglomeration council meetings may be held in March 2012 for which members of the municipal council shall establish the stance that it wishes to take;

SECOND QUESTION PERIOD

The second question period started at 9:25 p.m. and finished at 9:27p.m. Two (2) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident inquired as to whether the City looked in to a synthetic product to remove ice from the roads and sidewalks instead of salt to which Councillor Erdelyi replied that the City uses various mixtures which react best with the actual temperatures outside.

The resident sought particulars regarding the City's upkeep of its water main system considering, in his view, when the system was the property of the City of Montreal, it was not properly maintained. Mayor Housefather explained to the resident that since the City took ownership of its water infrastructure (which belonged to the City of Montreal even prior to 2002) it has done extensive repairs and maintenance on it. He further explained that the City has sleeved many of its pipes which will extend their life.

2) Irving Itman

The resident inquired as to what occurs if there is a surplus within the snow removal budget to which Mayor Housefather responded that it would be transferred to the City's Accumulated Surplus budget account.

The resident opined that there is a high leakage rate of water for which Mayor Housefather clarified that, to avoid leakage and to save costs on water the City had performed (and will continue to perform) sleeving on its water infrastructure.

The resident then inquired as to when Public Works will ensure that certain defective street lighting is not on during the day to which Councillor Erdelyi responded that the Public Works department's priority is to fix the burned out lights but will look into this situation as well.
