MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, JUNE 11, 2012, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

QUESTION PERIOD

The question period started at 8:00 p.m. and finished at 8:50 p.m. Nine (9) people asked to speak and they were heard.

1) Ruth Benor

The resident went on record as stating that homeowners who themselves or by way of their gardeners blow leaves on to City streets should be fined. Mayor Housefather explained that the City will be even more proactive in looking into this matter now that it recently adopted a by-law obliging contractors to pay a license fee (and that they are now even more identifiable).

The resident then went on record as stating there is an issue in the City with residents putting out their garbage outside of collection hours and contacted a dispatcher requesting that Public Security follow up but no action was taken. Mayor Housefather then stated that Mr. Pontbriand, the manager of operations, would look in to this complaint.

Lloyd Pedvis

The resident requested that the City enforce its smoking by-law and apply a loitering by-law due to disruptive youths being in the parks late at night for which Mayor Housefather clarified that the applicable by-law in question is the one wherein there is an infraction for being in the park past 11:00 pm. Moreover, Mayor Housefather explained that the City has requested that the police patrol the area and enforce the by-law (concerning park hours) as well as request that the youths be disbanded from the area.

The resident then requested that the City install traffic-calming measures on Shalom to which Mayor Housefather stated that the Traffic Committee can look in to the resident's suggestion.

3) Mike D'allesandro

The resident advised Council of a vacant lot near Trinity that has not properly cut their grass to which he responded that the Urban Planning Department can look in to the matter. The resident then stated that there is an immovable with its aluminum siding half off to which Mayor Housefather stated that the Urban Planning Department can look in to this matter as well. The resident then stated as that the streets near Imagination Park need to be cleaned to which Mayor Housefather then responded that the contractor doing work in that area can be alerted so he may clean the streets.

4) Russell Samuels

The resident complimented members of council for doing a fine job. He then inquired regarding the status of Fyon Park as recently, the swings in that park have been removed and there are shards of glass in the sand (from broken beer bottles) to which Mayor Housefather responded that someone from the City can look in to this matter and return to the resident with an answer.

5) Steven Vita

The resident tabled a study with the City Clerk on the positive effects of green space on health and called upon the City not to amend its by-law governing the tree protection to render the rules concerning the felling of trees more lenient. Mayor Housefather explained to the resident that, in reference to the City's by-law concerning the protection of trees, the City has been actively working with its engineers and urban planners so they can be properly advised on this issue.

6) Al Hayek

The resident called upon the City not to amend the City's by-law governing tree protection to render the rules concerning the felling of trees more lenient. The resident then explained that mature trees help temper the effects of heat and the City should thus take this in to consideration when rendering decisions on the quantity of trees replacing those felled. Mayor Housefather explained to the resident that the City's general practice is to issue a *one-for-one* tree replacement directive and that each request is carefully vet.

7) Shoshana Felig

The resident went on record as objecting to the Minor Exemption request at 6525 Merton as the neighbour's retaining wall's (underground) footing encroaches on her property. Mayor Housefather then clarified for the resident that the Minor Exemption request deals with a swimming pool and not the retaining wall.

8) Toby Shulman

The resident called upon the City to verify the cleanliness (and operational capacity) of each of its parks more often; citing examples in support of her assertion. Mayor Housefather explained to the resident that the City can pass on her comments regarding i.e. Arthur Zygielbaum Park and Glenn J. Nashen Park to its Public Works Department.

9) Cindy Sultan

The resident complained regarding the current state of Fyon Park citing examples of children consuming drugs in that park, leaving cigarette butts in the sand, an

unclean bathroom, a need for mats for kids, toys being old and beer bottles left strewn all over the park. Mayor Housefather explained to the resident that the City will look into the current state of the park including the issues related to cigarette butts and beer bottles.
