### **QUESTION PERIOD**

The question period started at 8:03 p.m. and finished at 8:24 p.m. Four (4) people asked to speak and they were heard.

### 1) Maurice Elia

The resident sought particulars regarding the hours that gardeners and construction workers can work within the City to which Mayor Housefather responded that the City Clerk can clarify the exact hours for the resident should he so require. The resident then went on record as stating that gardeners and construction workers should be prohibited from working too early in the morning. The resident then went on record as stating that the City should ban leaf blowers.

# 2) Rhoda Albert

The resident inquired as to the City's future plans for its snow dump to which Mayor Housefather responded that the area in question will remain a snow dump.

The resident then complained that there is currently gravel at or near the snow dump which took a month to clean up to which Mayor Housefather responded that the dirt was a result of construction and that the City subsequently asked that the developer spray and water the area.

## 3) Irving Itman

The resident sought an update concerning the Cavendish Extension to which Mayor Housefather responded that this project is an Agglomeration one which also requires provincial funding but that the City has been at the forefront in terms of requesting that it move forward. Mayor Housefather further added that the City will be proactive in inquiring as to whether the Agglomeration has allotted the necessary funds in their upcoming Capital Expenditures Budget to move this project forward.

# 4) Toby Shulman

The resident requested that composting be available city-wide to which Councillor Erdelyi responded that it has been indeed implemented in phases.
