## **QUESTION PERIOD**

The question period started at 8:05 p.m. and finished at 8:35 p.m. Four (4) people asked to speak and they were heard.

## 1) Maureen Hopman

The resident opined that skateboarders should be compelled to wear helmets within the City and inquired as to whether the City will be updating its compulsory helmet by-law accordingly to which Mayor Housefather responded that tonight, Council is indeed giving a Notice of Motion to amend its current by-law and is seriously contemplating its adoption.

# 2) Steven Hopman

The resident went on record as agreeing with the previous resident regarding the compulsory wearing of helmets for skateboarders.

Councillor Nashen then explained to the public that Côte Saint-Luc's current by-law compelling the use of helmets was one of the first of its kind in Quebec and the City of Côte Saint-Luc has been a leader and pioneer in regulating helmet use for activities such as cycling and in-line skating.

## 3) Irving Itman

The resident inquired as to when the signage for the Speed Limit on Mackle will be adjusted in conformity to the most recent by-law coming in to force to which Director Raggo responded that the Public Works Department is currently working on it and all appropriate signage should be replaced imminently.

The resident inquired as to whether it would be expedient for the City to lead a petition concerning Bill 14 to which Mayor Housefather responded that there is already a venue through the National Assembly to petition and that he will ensure, when he does his presentation tomorrow before a parliamentary commission, that the residents' views are heard as loudly and clearly as possible.

The resident then inquired as to whether any contracts issued illicitly by the Agglomeration may give rise to a reimbursement to the Agglomeration taxpayers to which Mayor Housefather responded that Mayor Applebaum has stated that City of Montreal (with the majority of votes at the Agglomeration) would ultimately decide as to whether or not to pursue anyone regarding the preceding matter. The resident then went on record as opining that the matter should indeed be pursued.

## 4) Jeff Potofsky

The resident inquired as to whether or not the City ordered any balconies from the Presidential Towers to be replaced because they were unsafe. He then further inquired as to whether the City opined as to whether or not certain condominium owners should indeed have to pay for the repairs to which Mayor Housefather responded that he has never been made aware of any such opinion by the City relating to this matter. Urban Planning Manager Davey then went on record as stating that had no knowledge of any such opinion either.
