QUESTION PERIOD

The question period started at 8:00 p.m. and finished at 9:00 p.m. Five (5) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident went on record as being disappointed that there may potentially be a commercial establishment built between the Chabad Synagogue and Bialik High School on Marc Chagall.

The resident then inquired as to whether the City of Côte Saint-Luc is compelled to pay its apportionment regarding Agglomeration-related services to which Mayor Housefather responded that it is.

The resident then sought particulars concerning the City of Montreal's approach regarding suppliers who acknowledge their guilt at the Charbonneau Commission to which Mayor Housefather responded that the City of Montreal has made certain pledges concerning the recovery of monies from these suppliers which Mayor Applebaum has asked his legal department to look in to.

The resident then called upon those (provincial and federal governmental entities) responsible, to move the Cavendish Extension Project forward.

The resident then stated that there is a recycling problem in his condominium dwelling as he does not have sufficient access to recycling bins to which Mayor Housefather stated that since Beatrice Newman; Manager, Waste and Environment, is currently in the audience tonight, she will introduce herself to the resident so he may advise her of his issue.

2) Irving Itman

The resident complained regarding the state of the stairs on Wavell, leading to Westminster. He also complained regarding the state of the retaining Wall on

Westminster. He then requested that the Public Works Department perform a cleaning of Wavell, near the bushes or railway tracks. Mayor Housefather responded that the Public Works Department can look in to what can be done regarding each issue raised tonight.

The resident then inquired regarding the logistics of the upcoming Municipal Election to which Mayor Housefather referred the resident to the City Clerk.

The resident then went on record as stating that that City has a super Council as well as a super Mayor.

3) Robert Ann Caplovitch

The member of the public sought particulars regarding police ethics complaints and the role, at the Agglomeration level, of such complaints to which Mayor Housefather responded that there is a Public Security Commission which may be involved but investigations of the SPVM, for example, are conducted at the provincial level by the Sûreté du Québec.

4) Toby Shulman

The resident asked that the parking lot in back of City Hall be repaired to which Mayor Housefather directed the request to Charles Senekal, in the audience tonight, so that he ensure that Public Works indeed perform the necessary repairs.

5) Gerald Kreaden

The member of the public stated that he is very in awe of what Côte Saint-Luc has accomplished as a City and wished that the City of Montreal was as effective.

The member of the public then stated that he is a member of the transport commission of the Cummings Centre for Seniors. He stated that he is requesting a shuttle bus leaving Côte Saint-Luc (especially during early morning hours) and stopping at the Jewish General Hospital as this service is required for individuals to go to the hospital, sometimes for their Doctor's appointments. Councillor Berku responded that the City is indeed looking in to this suggestion.
