MINUTES OF THE SPECIAL MEETING OF THE CITY COUNCIL HELD ON MONDAY, MAY 27, 2013, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

QUESTION PERIOD

The question period started at 7:05 p.m. and finished at 7:24 p.m. Three (3) people asked to speak and they were heard.

1) Toby Shulman

The resident called upon the City to have composting for its condominiums and Multi-family dwellings to which Mayor Housefather responded that this practice does not generally exist in municipalities as it is quite difficult to implement.

The resident then called upon the City to repair its City Hall parking lot to which Mayor Housefather responded that such repairs can only take place weather-permitting.

2) Irving Itman

The resident praised the City's Dramatic Society's performance of its play "Fiddler on the Roof".

The resident inquired as to whether there was a back-up system concerning last week's incident when the Montreal Agglomeration declared a water boiling advisory. Mayor Housefather clarified for the resident that any back-up plan would be comprised of being informed that the water levels are low (vs. an alternate source of potable water emanating from different underground piping). He further clarified that there is a feed-back system in place to look in to such matters.

The resident then inquired concerning the timing of the (Left Hand Turning) traffic signals on Kildare, turning on to Cavendish to which Mayor Housefather responded that the Left Hand Turn signals have recently been extended and the traffic flow has thus improved.

3) Dr. Bernard Tonchin

The resident requested that there be composting in Multi-Family dwellings to which Mayor Housefather responded that such an endeavour is not projected to happen in the near future.

The resident then called upon Council to implement a programme to have its residents purchase non-disposable diapers (such as cloth diapers) to which Mayor

Housefather responded that such a programme would be more appropriate to be implemented at a Provincial level.

The resident then went on record as stating that: the City should encourage its residents to attend Council Meetings and it should repair its City Hall parking lot.
