# IT – FIBRE OPTIC INTERNET ACCESS WITH COGECO

WHEREAS the City of Côte Saint-Luc ("City") issued an invited tender to five potential suppliers under file number C-22-13 for a three-year contract for two Internet connections at 100 megabits per second with 28 IP addresses and on-site support, and three companies submitted bids;

WHEREAS the bid of Cogeco Inc. was the lowest conforming bid;
