AMENDMENT TO RESOLUTION 131201 AUTHORIZING THE DEMOLITION OF THE FORMER INSTITUTIONAL BUILDING LOCATED AT 5760-5790 PARKHAVEN - REDUCTION OF MONETARY GUARANTEE FROM \$2,445,260 TO \$1,166,000 - AMENDMENT TO ANNEXES A, B, C OF RESOLUTION 131201 TAKING IN TO CONSIDERATION A REVISED TIMELINE

WHEREAS on December 9, 2013, the Côte Saint-Luc City Council ("Council") adopted resolution 131201 authorizing the demolition of the former institutional building located at 5760-5790 Parkhaven situated on Cadastral lot 10533551 subject to various terms and conditions including a series of annexes;

WHEREAS, pursuant to the criteria delineated within by-law 2345 ("By-law"), one of the aforementioned terms and conditions was the obligation to provide a Monetary Guarantee ("Guarantee") in the amount of \$2,445,260 based on the 2013 Building Evaluation ("Evaluation") of the existing building;

WHEREAS, considering the requester now wishes to provide a revised timeline for reconstruction and considering the requester wishes to demolish in 2014, Council wishes to use the 2014 Evaluation in order to calculate the amount of the Guarantee;

WHEREAS, the Manager of Urban Planning, Mr. Jeff Davey, has provided Council with the 2014 Evaluation said Evaluation being \$5,830,000; the 20% requirement within the By-law totaling \$1,166,000;

THAT correlative to said reduction, Council hereby authorizes the following revised annexes: A, B and C replacing the original annexes contained within resolution 131201;

THAT all other terms and conditions within resolution 131201 - including, but not limited to, the use of the monetary guarantee if ANY condition within resolution 131201 or this resolution is not fulfilled - shall have full force or effect."


