# OTHER BUSINESS - COUNCILLOR MITCHELL BROWNSTEIN - COMMENTS CONCERNING THE MOST RECENT PROVINCIAL ELECTIONS

Concerning the results in the most recent Provincial Elections, Councillor Mitchell Brownstein, stated the following:

"The City of Côte Saint-Luc has always taken a stand in favour of Canadian Unity. In the 1990's, I was proud to be on this Council when we were fighting in favour of the Charlottetown Accord; we met with municipal councillors across the country. In the 1990's we spoke of remaining part of Canada, in 1996, after the referendum; and most recently against Bill 14 and Bill 60.

What I have always felt - and I feel the time has come and if we look at the numbers and the popular vote and the numbers of this election - I think we should feel comfortable to tell our children and our grandchildren and let them realize how lucky they are to live in a City that is part of the Island of Montreal, with a European flavour and a beautiful province with two languages in a leading federal democracy that is respected throughout the world and that there is no place like home and that is Montreal. The talk has to be: Montreal, Suburban Municipality, Côte Saint-Luc. You don't have to travel an hour and a half in Toronto to get to work. You can live in Montreal. The cost of housing: whether it is buying real estate, renting an apartment, doing business here; it is cheaper. There are great opportunities here. We are one hour away from our lakes and our mountains and our American neighbours. We live in an ideal place and as an Immigration attorney, I have been saying this for years. When I fly back to Canada, I arrive from Toronto or Vancouver when I am coming from Asia, Africa or Europe; and I still do not feel like I am at home until I take that last flight to Montreal. This is our home and it is a great place.

If there was a referendum on Monday, the percentage of the polls to me says that at least 65% of Quebecers would say that they want to remain in Canada and the polls show, that our youth, the 18-24 year olds, voted 2-1 against the Parti Québecois. They are our future. They are the people that feel connected both to the global community, to Canada and to Quebec and they are interested in the jobs and the economy. They're the future so you can stay here - whether you are Anglophone, Francophone - together and be a part of a future in one of the greatest places in the world to live which is Quebec, the Island of Montreal, Côte Saint-Luc."
