URBAN DEVELOPMENT – AWARDING OF A CONTRACT FOR THE INSTALLATION OF A BACKUP GENERATOR AT THE ACC, CONSTRUCTION SERVICES (ENG 2014-11) (C-24-14)

WHEREAS the City of Côte Saint-Luc ("City") issued a public tender (C-24-14) for the installation of a backup generator at its Aquatic and Community Centre ("ACC") and received (1) conforming bid from La Cie Britton Électrique Ltée ("Britton");

WHEREAS the City was entitled to negotiate the price offer of Britton pursuant to the Cities and Towns Act and it did so;

AUTHORIZATION TO SETTLE A CLAIM BY ASSURANCES GÉNÉRALES DESJARDINS (INSURER FOR JERUSALEM GIRMA) AGAINST THE CITY OF CÔTE SAINT-LUC

WHEREAS On June 9, 2014 the City of Côte Saint-Luc was jointly sued along with the City of Montreal by Assurances Générales Desjardins for \$10,881.40 with additional expenses (not yet quantified) to follow;

WHEREAS the basis of the litigation was damages to an immovable due to a break in a fire hydrant line with water allegedly then entering the basement at 7119 Kildare;

WHEREAS On August 27, 2014, the proceedings were amended adding expenses (since quantified) for a total amount of \$29,333.83;

WHEREAS the City wishes to amicably resolve the Claim;

THAT the Côte Saint-Luc City Council ("Council") hereby authorizes the City to settle the Claim against the City by Assurances Générales pursuant to case bearing docket number 500-22-212877-149 for an amount of \$9,250.00, inclusive of capital, interest and costs the whole subject to the City of Montreal undertaking to provide its share of the settlement as well as contingent upon the signature of a quittance on terms acceptable to the City of Côte Saint-Luc;

THAT Council hereby authorizes the Director of Claims and Litigation, or either of the City's General Counsel to sign any document giving effect to the foregoing;

THAT Treasurer's certificate number TC14-0158 dated September 19, 2014 has been issued by the City Treasurer, attesting to the availability of funds to cover the above-described expenses."

AUTHORIZATION TO ACCEPT MONIES FROM THE CITY'S INSURER CONCERNING DAMAGES SUSTAINED DUE TO A FLOOD

WHEREAS it is expedient to amend resolution 140618 to reflect the materials for which the City of Côte Saint-Luc must be reimbursed pursuant to a flood which occurred on January 31, 2014;

WHEREAS on or about January 31, 2014 at approximately 2:00 pm, a major flood occurred at the Bernard Lang Civic Centre located at 5801 Cavendish Boulevard;

WHEREAS the City of Côte Saint-Luc ("the City") sustained several damages pursuant to this flood;

WHEREAS the City's insurer, FM Global, wishes to disburse the monies owed to various suppliers and contractors pursuant to the expenses incurred necessary to remedy damages pursuant to said flood;

It was

MOVED BY COUNCILLOR DIDA BERKU SECONDED BY COUNCILLOR SAM GOLDBLOOM

AND RESOLVED:

"THAT the Côte Saint-Luc City Council ("Council") hereby authorizes the City to enter into a settlement with its insurer, FM Global, so that said insurer can disburse the following amounts:

- a) \$38,860.45 payable to Strone;
- b) \$9,661.22 payable to Qualinet; and
- c) \$1,991.25 payable to Viking;

THAT Council further approves the balance payable to the remaining suppliers by the City of Côte Saint-Luc being its recoverable portion of its GST and QST;

THAT pursuant to damages sustained to its floor located within the Harold Greenspon Auditorium, Council hereby authorizes the City to accept an amount of \$14,000.00 in full and final settlement as well as \$3369.97 in labour incurred and materials used pursuant to the said flood

THAT Council further authorizes the City to pay its insurer, FM Global, its \$10,000.00 deductible, the whole pursuant to the terms and conditions of its insurance contract;

THAT Council further reserves the City's rights to make any other claim the Director of Legal Services deems expedient;

THAT Council further authorizes the Director of Legal Services or either of its General Counsel to:

- Coordinate the payment logistics as they deem necessary; and
- Sign any document to give effect to the foregoing."
