AUTHORIZATION TO SETTLE A LITIGATION WITH ALLSTATE IN ALLSTATE VS. CITY OF CÔTE SAINT-LUC AND SIMO MANAGEMENT

WHEREAS Plaintiff, Allstate du Canada compagnie d'assurance ("Allstate") filed a Motion Introductive of Suit for damages and interest on December 20, 2013 claiming that co-defendants, the City of Côte Saint-Luc ("the City") and Simo Management Inc. ("Simo"), were liable for an amount of \$15,000, plus capital, interest, costs and special indemnity, said suit ("Suit") bearing docket #500-22-208531-130;

WHEREAS Allstate and the City wished to resolve the Suit without any admissions on either side of any nature whatsoever, including but not limited to, the responsibility of the parties and/or the quantum claimed;

WHEREAS on November 25, 2014 the City and Allstate began negotiations which subsequently culminated in a proposed settlement to resolve this present file by way of payment of \$4,250.00 in capital, interest, taxes and costs ("Proposal");

WHEREAS this Proposal is conditional upon the Côte Saint-Luc City Council ("Council") accepting it and adopting it by resolution at its Special Council Meeting tonight;

WHEREAS Council is being requested to authorize that the Proposal be consummated by way of *reçu quittance et transaction* ("Settlement") and that Jonathan Shecter, their Attorney of Record, as well as both of the City's General Counsel be authorized to sign any document to give effect to the foregoing;

AND RESOLVED:

"THAT the preamble of this resolution shall form an integral part thereof as if cited hereinafter at length;

THAT Council hereby authorizes the City to settle the Suit bearing docket #500-22-208531-130 by and between the City and Allstate only;

THAT Council hereby authorizes that said Settlement amount shall be \$4,250.00 in capital, interest, taxes and cost and shall be full and final;

THAT in consideration of this Settlement, Allstate shall give the City a full and final release receipt and discharge;

THAT Jonathan Shecter, the Attorney of Record, or either of the City's General Counsel shall be authorized to sign any document to give effect to the foregoing;

THAT Treasurer's certificate No.14-0182 dated December 11, 2014 has been issued by the City Treasurer attesting to the availability of funds to cover the above-described expenses."
