

Plan summary

The supplemental pension plan for the employees of the City of Côte Saint-Luc was created January 1st, 1960. The plan covers blue collars, white collars, professionals and management employees.

The plan is a defined benefit plan with a pension credit of 2 % of the five year average salary per year of membership. For service before January 1, 2012, the pension credit is subject to a maximum of \$1,143 per year of membership. For service beginning January 1, 2012, the maximum is \$1,625 per year of credited service for members who contribute 6% of their salary and it remained at \$1,143 for those members who contribute 5% of their salary.

All members can retire without reduction on the first day of any month that coincides with of follows their 60th birthday. Early retirement is allowed for all members 10 years preceding their unreduced retirement date. The pension then payable is reduced by 6 % per year between the effective retirement date and the unreduced retirement date.

The death benefit after retirement is a 50% reversion to the spouse. If there is no spouse at retirement, the pension is guaranteed for 5 years.

There is no post retirement indexation.



Financial position as at December 31, 2013

For deficit attribution purposes, the asset value is \$30,214,300, while the liabilities are \$32,630,100\$. The plan has a \$2,415,800 deficiency.

The deficit attributed to retirees is \$998,000 while the active members' deficit is \$1,417,800.

Contributions

Following the December 31, 2013 actuarial valuation, the required current service contribution payable by the City of Côte Saint-Luc is **11.2** % of pensionable earnings.

The employees' current service contribution is **5.9** % of pensionable earnings. The estimated pensionable earnings are \$11,158,400.

In addition of to the current service contribution, an annual amortization payment of \$266,400 must be made to the general account to fund the pension plan deficit. Since there is a reserve, the annual amortization payment required by the City is equal to \$133,200 and an equal amount will be transferred from the reserve to the general account.
