URBAN PLANNING - MINOR EXEMPTION - 5854-5880 KELLERT - CÔTE SAINT-LUC

"THAT in accordance with the provisions of by-law G18-0005, the request for a Minor Exemption regarding the property located at 5854-5880 Kellert, Lot 4574826, be and is hereby approved, the whole as more amply delineated hereunder:

The request is to allow an existing townhouse project facing Kellert Avenue to have:

- a) The ground floor wood balconies encroach 3,65m (12'-0") into the minimum side setback instead of the maximum allowable encroachment of 2,13m (7'-0") into the minimum side setback. The forgoing is in accordance with the provisions of Zoning By-law n° 2217, article 4-2-2;
- b) The driveway slope at 6.5% facing Kellert Avenue instead of the maximum allowable slope of 3% for a driveway facing Kellert Ave. The forgoing is in accordance with the provisions of Zoning By-law n° 2217, article 7-5-9; and
- c) The visitors parking area located at 0,81m (2'-8") from the ground floor wall of the building instead of the minimum required distance of 3,04m (10'-0") from the ground floor wall of the building. The forgoing is in accordance with the provisions of Zoning By-lawn° 2217, article 7-2-9."
