### **QUESTION PERIOD**

The question period started at 8:03 p.m. and finished at 8:26 p.m. Four (4) people asked to speak and they were heard.

# 1) Dr. Bernard Tonchin

The resident suggested that the City serve food refreshments at its Council meetings for which all members of Council took note.

### 2) Rhoda Albert

The resident congratulated Councillor Glenn J. Nashen concerning a most recent article in the Suburban.

The resident then inquired as to whether Municipal tax payments that are owed can be divided in to four installments instead of just two installments to which Mayor Housefather responded that this suggestion would unfortunately not be expedient to be implemented in the City of Côte Saint-Luc.

### 3) Irving Itman

The resident wished to go on record as having full confidence in Mayor Housefather's administration.

The resident then inquired regarding certain Agglomeration loans for which Mayor Housefather explained their logistics.

The resident then requested that the Public Works Department be particularly vigilant concerning Fire Hydrants covered in snow to which Mayor Housefather responded that Public Works could indeed be particularly vigilant regarding that matter.

The resident then went on record as supporting zoning to allow temporary winter shelters for cars for certain individuals as, in his view, there are different circumstances that require certain home owners to have such shelters. Mayor Housefather then clarified for the resident that zoning must be done by immovable (vs. by person), that council has deliberated upon the matter on several lengthy occasions (giving it its full importance) and that, when such a need arises, the City works with that particular individual to ascertain as to whether a feasible and humane solution can be had.

### 4) Cedric Zeitouni

The resident explained that this year is the 35<sup>th</sup> Anniversary of the Terry Fox Marathon of Hope and in commemoration of this event he recommended that Council rename a park after Terry Fox. Mayor Housefather explained to the resident that the City has a Toponomy Committee that entertains these types of proposals but that the naming of a park after Terry Fox would not be feasible. Mayor Housefather then solicited any other suggestions in terms of honouring Terry Fox (which the resident did not have at this time).
