Substance of By-Law 2217-YY-P1

A discussion then ensued with various Members of Council explaining their view of the project (with Councillor Allan J. Levine asking that his comments be transcribed on record).

Mayor Anthony Housefather:

"Just to come back to the situation, the City owns a piece of land next to the Côte-Saint-Luc shopping centre. B'nai Brith and other senior organizations that own senior properties in the City were given a chance by the City to come forward with a proposal to make use of that land for affordable housing for seniors.

B'nai Brith was the only one in the end that actually came forward with a proposal. The other potential bidder, which was Federation CJA that owns the Caldwell residences, supported the B'nai Brith project. Saint Patrick's Square also ended up supporting the B'nai Brith project that came forward.

Council had extensive discussions about this; whether this was the best use of the land, whether this would be a project that was needed in the community, and the majority of Council came down with the feeling that this was a very heavily needed project in the community so that seniors moving out of their homes in the community could find affordable housing and live in Côte-Saint-Luc.

B'nai Brith mentioned there is a very very long waiting list for this project and B'nai Brith agreed most of the initial residents will come from people that already live in Côte-Saint-Luc.

Concern with regard to proximity to railway tracks

Other members of council had some issues with the location of the land in the fear

that it was close to railway tracks and the fear of seniors living too close to railway tracks, which is a legitimate concern in the design of the project.

Council did their best to work with B'nai Brith and our staff to come to a project with sound proofing and berms, and all the most modern technological ways to make the building as safe and soundproof as possible.

Most of Council came down on the side that this is a very important project that needs to happen. There are a couple members of Council, at least 1, who has more hesitation and is not in agreement with the project for those reasons of concern about safety.

In the end, that is sort of where we are right now and I will now let any member of Council that wants to speak, to speak to this issue.

Councillor Berku:

Thank you.

So, while I fully support and endorse a new B'nai Brith residence in Côte-Saint-Luc for vulnerable deserving seniors, and certainly those who come from Côte-Saint-Luc, and I understand the location along Côte-Saint-Luc Road next to the shopping Centre is convenient and, under normal circumstances, almost ideal to have a senior residence so close to a shopping centre (the appropriate proximity to shops, so on and so forth), for me personally, and I struggled with this a lot because when you sit as a City Councillor there is very often conflicts of use and this is what we have to manage.

When B'nai Brith first came to see us about this project, I raised the issues of proximity to the railways and their response was, as the Mayor said, to provide us with designs that include berms and sound barriers and the maximum distance they can go from the railway track in order to meet their requirements for 120-odd units.

For me, it is still not enough and so the issue with proximity to the railways is still an issue I am struggling with. I just do not feel that proximity can be ignored. In light of what happened at Lac Megantic, and I know it was a very exceptional circumstance, but there were 47 people killed and multi-million dollars-worth of damage caused.

Here you are building a 6-storey senior residence within the 30 metre right of way, because the 30 metre setback that is proposed by the Federation of Canadian Municipalities says it should be built 30 metres from the right of way from the railways. We are within those 30 metres because by some kind of fancy measurements, they measured from the middle of the track so we do not know if it is 15 or 20 metres from the right of way.

For me, it is definitely too close. At this point, until we see the final design, because we have a design and it has been approved in principle or submitted to PAC a couple of times, there have been some debates about it, we are going to the final design. Until such a time as we do see that final design, I am not going to vote in favour of this project or the rezoning.

Basically, I am just not prepared to take that risk. I cannot make that leap of faith that everything is going to be fine and residents are going to be protected in this 6-storey building which, in case of an emergency, we would have to evacuate residents that would be living right next to a possible train derailment.

I am not saying it is going to happen. We live in Côte-Saint-Luc. We know most of Côte-Saint-Luc is built around the railway tracks, and close to the railway tracks; and we have many homes that are within 10 metres from the railway tracks, but to me, that is not a reason to repeat the mistakes of the past.

I feel going forward we should comply as much as possible and to the best of our ability and majority Council feels that we have, and I am just not there yet. I do not think we have complied with the new guideline, because in my mind, 30 metres is a minimum setback and it has not respected that setback.

I just feel that it is just too close and I personally am not prepared to take that risk given the circumstances we know, and since Lac Megantic, because of the millions of barrels of oil being transported across North America, Canada, the U.S. We have had multiple derailments; every week, every month, there are derailments and some are more serious than others. It is something we should take into account and not build new "sensitive housing", because that is what they call it, Federation of Canadian Municipalities calls it "sensitive housing", because it is senior residents so close to the tracks where we would have to evacuate over 150 residents in the event of an emergency.

Mayor Anthony Housefather:

Thank you Councillor Berku. Councillor Kovac.

Mitigating Measures

Councillor Kovac:

Thank you, Mr. Mayor.

I think each person on Council would love to be able to say it is very nice, it is motherhood and apple pie.

I get it, you feel that it is not far enough away from you, but what you are really telling the residents on Wallenberg, Vincelli, the J.P.P.S Garderie, the TPDJ synagogue that can have up to 800 people at one time, Mount Sinai Hospital - I am going around the City- the relocation of Adar (which you¹ voted for), Blossom/Mackle where the old pool was, you voted for a new development at that time, the Côte-Saint-Luc shopping Centre can have 1000 people there at one time, Wavel homes, the Baily homes, the Ecole Yavné, where you voted for the extension, you have children in there, that is sensitive.

I mean, what message are you sending to all the residents of Côte-Saint-Luc? That you should move everything a little further away, that we should live in fear?

Let me tell you something. This building has been approved by PAC, it has gone through multiple revisions. This is probably going to be the safest building in proximity to a railway. This will be the safest building so these people are at the least risk from all the other places that, if you just do a mental trip around the City, you will see how many people are in close proximity- your building as well, where you live on Marc Chagall. I live a block and a half away from the railway (and near the trains), at quarter-to-two in the morning, I am very well aware how close I am.

I am telling you (and) the entire City; you take a train to Quebec City, go by train to Toronto, go by train to Ottawa, there isn't a community that isn't near the railway. The Country² was built on it. It wasn't built on fear, it was built on Commerce and Progress.

I think giving a place of respect for seniors to live, when they cannot afford it, after they move out of their homes, to give them a place to live that will be the safest place to live in proximity to a shopping centre is probably the best thing that Council can do for them; not the worst thing, the absolute best thing.

Mayor Anthony Housefather:

Thank you Councillor Kovac. Councillor Levine.

Councillor Levine:

Like the Rabbi said, you're both right.

Dida has every right to fear putting a building where many citizens, or senior citizens, are living next to the tracks. However, B'nai Brith went out of their way to make it as safe as possible. You look at the other side, because you know we have to live in a

grey area, the grey area we are looking at is the need for this type of housing; it is tremendous.

The fact that the Quebec government is paying for a very large portion of it, because B'nai Brith got a grant for this, we would be giving up the money for low cost housing given free from Quebec. The project has already had to spend a lot of extra money because we were very tough. It is okay if we are tough, now I feel it is safe as well.

Many people who live in my area are going to move, they already have their name registered to move in there. It opens the home, the empty nesters, young families move into the area as well. It is mixed housing, it makes some people pay a lot because they are wealthy and many people pay next to nothing because they cannot afford it. It is a mix, it is not elitist in any way, it is a mixture of people getting together and living together and helping each other, it is really the best of all worlds.

Like I said, I do not think Dida is more right than Ruth, I think they are both right and Council did everything to come up with the best possible solution.

Mayor Anthony Housefather:

I would just like to mention a couple of other points:

First, It is not like we have the luxury of multiple other locations where we could locate a new building. Côte-Saint-Luc is essentially built-up. This is essentially the sole land the City had that we owned that could possibly be used for such a building without removing park lands.

Second, I understand it is always a balance of risk. Everybody has to make a judgment as to what makes the most sense.

To me, the idea that we deprive 150 people of a pleasant place to live for the 15-25 years they have left to live, hopefully, because of the infinitesimal chance that in that one location there may be a train derailment that is dangerous, when you balance the considerations, I would rather the people have the chance to live in a good environment in the City they feel comfortable in.

B'nai Brith is not a risky organization- it is an internationally recognized charitable organization. Their judgment is not going to place a building in a place where they think that it is risky and dangerous. Multiple experts we have spoken to from B'nai Brith, our City, outside, said they consider the design to be 'legitimate' and 'okay'. Even that, against the small risk of a catastrophe happening, that theoretically, as Councillor Kovac said, could happen anywhere in the City if things don't go right. This is the real reason we need the Federal government to become tougher on the rules related to locomotives in this Country and make sure we have safer designs. That is the real answer to this question, but in the meantime every site is legitimate, I think we all recognize that."

WHEREAS according to section 58 of the Act, every central municipality has an urban agglomeration council, the nature, composition and operating rules of which are set out in an order in council and that this agglomeration council constitutes a deliberative body of the municipality;

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the Mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the Mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance:

WHEREAS agglomeration council meetings may be held in August 2015 for which members of the municipal council shall establish the stance that it wishes to take;

AND RESOLVED:

"THAT Council take the following stance in view of any Agglomeration Council meetings to be held in August 2015 as follows:

- to authorize the Mayor or his duly authorized replacement to make any decisions he deems necessary and in the best interest of the City of Côte-Saint-Luc and its residents regarding the items on the agenda of the Agglomeration Council meetings to be held in August 2015 based on the information to be presented during those meetings."

1) Roberta Anne Capelovitch:

The resident requested that the City start a task force to relocate rail yards to which Mayor Housefather responded that this was not a City responsibility as rail yards are a federal jurisdiction. The resident then inquired as to how the City would respond to a rail derailment to which Mayor Housefather responded that the City of Côte-Saint-Luc has an Emergency Measures Plan for all forms of emergencies.
