RESOLUTION AUTHORIZING COUNCILLOR DIDA BERKU TO ATTEND ALL AGGLOMERATION COUNCIL MEETINGS AS WELL AS ALL MEETINGS WITH THE ASSOCIATION OF SUBURBAN MAYORS UNTIL A NEW MAYOR IS ELECTED AND SWORN IN

WHEREAS Mayor Anthony Housefather was a candidate in the most recent Federal Election held on October 19, 2015;

WHEREAS Mayor Anthony Housefather was successful in winning the seat for the Mount Royal Riding and therefore became a Member in the House of Commons in Canadian Parliament;

WHEREAS as result of Mayor Housefather's Federal Election victory he was compelled to resign as Mayor in order to fulfill his duties in the House of Commons;

WHEREAS on November 2, 2015 Mayor Anthony Housefather resigned as of effective date November 4, 2015 at 12:01 a.m.;

WHEREAS as part of Mayor Anthony Housefather's former duties he would regularly attend Agglomeration Council Meetings as well as attend meetings of the Association of Suburban Mayors ("Association");

WHEREAS either the Acting Mayor or another Member of Council must now represent the City of Côte Saint-Luc at the Montreal Island Agglomeration Council Meetings as well as of the Association meetings;

WHEREAS it may not be expedient for the current Acting Mayor to attend Agglomeration Council Meetings as well as Association meetings;

WHEREAS the Côte Saint-Luc City Council deems it expedient to appoint Councillor Dida Berku as the Member of Council to sit at Agglomeration Council Meetings until a new Mayor is elected and sworn in for the City of Côte Saint-Luc as well as to attend Association meetings;

WHEREAS in the event that Councillor Dida Berku shall be absent and/or unable to attend said Agglomeration Council Meetings, or Association meetings the Acting Mayor shall designate another representative;

WHEREAS resolution number 051207 already provides for a mechanism to allow Councillor Dida Beku to attend Agglomeration Council meetings and now requires being updated due to the Mayoral vacancy;

AND RESOLVED:

"THAT the Côte Saint-Luc City Council hereby appoints Councillor Dida Berku, as a representative of the Côte Saint-Luc City Council to attend all Agglomeration Council Meetings and Association meetings until a new Mayor for the City of Côte Saint-Luc is elected and sworn in;

THAT in the event the aforementioned Councillor Dida Berku is unable to attend said Agglomeration Council Meetings or Association meetings, a representative shall be designated by the Acting Mayor."

APPROVAL TO REQUEST AN EXTENSION OF THE TIME TO CALL A BY-ELECTION TO FILL THE MAYORAL VACANCY

WHEREAS the resignation of Mayor Anthony Housefather was tabled on November 9th, 2015 (the "Notice of Vacancy Date") before the City Council at its Regular public Sitting; which resignation creates a vacancy in the position of Mayor of the City of Côte Saint-Luc ("City") requiring a Mayoral By-election in 2016;

WHEREAS under Section 339 of the *Act Respecting Elections and Referendums in Municipalities* ("AERM"), a Mayoral By-election must be called by the Returning Officer within 30 days of the Notice of Vacancy Date, setting the By-Election Polling Day for a Sunday within 4 months of the Notice of the Vacancy Date, subject to the granting of a request by the Minister of Municipal Affairs and Land Occupancy ("MAMOT") to extend such Polling Day to a Sunday even outside the 4-month period, with or without any adaptations to the rules of such By-election that the MAMOT shall deem appropriate at its discretion;

WHEREAS given that: **(a)** among the list of qualified voters, there is a numerically substantial, vibrant and engaged senior demographic residing in the electoral district of the City who travel south for the winter season where they live primarily in Florida (U.S.A.) for the months of December, January, February and March, and only return to the City of Côte Saint-Luc in the month of April; <u>and</u> **(b)** it is in the best interests of the City to maximize the democratic process and voter turnout by including as many of these seniors as possible in the By-election process; it is in

the best interests of the City to request an extension of such By-election Polling Day to a day outside of this 4-month period;

It was

MOVED BY COUNCILLOR RUTH KOVAC SECONDED BY COUNCILLOR STEVEN ERDELYI

AND RESOLVED:

"THAT the Preamble hereto shall form an integral part hereof as if recited at length;

THAT the Returning Officer/President of the By-election, namely, Cheri Bell, be and is hereby authorized to request an extension of the Mayoral By-election Polling Day to Sunday, April 10th, 2016, with or without such adaptations to the rules of the By-election that the MAMOT shall deem appropriate at its discretion, the whole in accordance with the second paragraph of Section 339 of the AERM;

THAT pending the outcome of the decision of the MAMOT, such decision coupled with this Resolution may constitute the basis for the Notice of (By-) election to fill the Mayoral vacancy arising from the resignation of (former) Mayor Anthony Housefather, tabled before the City Council on the Notice of Vacancy Date."
