TABLING OF LETTER OF RESIGNATION FROM COUNCILLOR MITCHELL BROWNSTEIN

That pursuant to the law, the City Clerk tabled a letter entitled: "Resignation" dated February 8, 2016 from Councillor Mitchell Brownstein at tonight's council meeting, said resignation effective at 11:59 p.m. on February 8, 2016.

HONOURING OF DR. MARK WAINBERG:

Acting Mayor Dida Berku explained to the public that Dr. Mark Wainberg, in the audience tonight, received a letter from the Consul General of Israel. She further explained that this letter congratulated Dr. Wainberg for having recently donated a Torah in memory of an Ethiopian Jew who died at the Israeli gay pride parade. A photo of Dr. Wainberg with all Members of Council present tonight at the Regular Council Meeting was then taken in his honour for his actions.

QUESTION PERIOD

The question period started at 8:05 p.m. and finished at 8:48 p.m. Eight (8) people asked to speak and they were heard.

1) Mary-Joy Klein

The resident inquired as to whether this summer there would be an early morning swim at the *outdoor pool* (vs. the indoor pool) earlier than the time allotted as 8:00 am was too late for those who wish to participate in an early morning swim and then go to work to which Councillor Brownstein responded that Manager Levine would look into all alternatives to ensure the best possible service for the City.

2) Kim Malka

The resident stated that she is here in tonight's audience in her capacity as President of Maimonides Côte Saint-Luc Daycare. She further stated that two specific parks were not gated, said parks being Edgemore and Fyon. She requested that said parks be gated so that daycares can actually avail themselves of the use of said parks. The Director of Public Works, Beatrice Newman, in the audience tonight, agreed to work with the resident and return to her with a definitive answer.

3) Dr. Bernard Tonchin

The resident wished to go on record as thanking Councillor Mitchell Brownstein for the service he has offered the City of Côte Saint-Luc as a Councillor for his district. He then wished him the best of luck in his quest for the Mayoralty.

The resident then inquired as to how soon the district by-election would occur now that Councillor Mitchell Brownstein has declared his intention to resign tonight at 11:59 pm. Acting Mayor Berku responded that the reason Councillor Brownstein shall be resigning is that he wishes to save the City money by allowing it the requisite time to hold concurrent by-elections; one for Mayor and one for the Councillor in District 7. Acting Mayor Berku then explained to the resident that said concurrent by-elections shall occur on Sunday, April 10, 2016.

The resident then wished to go on record as welcoming the ex-Mayor of the City of Côte Saint-Luc and current Member of the House of Commons, Anthony Housefather, and wishing him the best of luck.

4) Eyal Gamliel

The resident requested that the City look at the parking/security issue on Wavell at Yavné School and inquired as to what the next step in the process was. Acting Mayor Berku stated that today was the first she heard of the problem and that considering that both the Directors of Urban Development and Public Safety are currently in the audience tonight, the resident should approach both of them directly and start corresponding with them. She further stated that the resident's requests will be taken into consideration.

5) Irving Itman

The resident inquired as to whether Hudson and Wolseley (between Guelph and Wavell) will be resurfaced in the near future to which Acting Mayor Berku responded that Director Senekal will review the resident's request to see if both streets merit intervention.

The resident then inquired if there could be further signage indicating the speed limit on or around Westminster at the *École de la Mosaïque* School so that it be clarified what portions of the speed limit are 30/km (vs. other speed limits) to which Acting Mayor Berku responded that the City can take the suggestion under advisement.

The resident then inquired as to what is being done concerning the Cavendish extension to which Acting Mayor Berku stated that she has recently attended a technical meeting and the City of Montreal is negotiating to buy land in order to create a public *right-of-way*.

6) Sharon Freedman

The resident went on record as stating that her presence tonight was in view of supporting Councillor Mitchell Brownstein as a candidate to be the future Mayor of the City of Côte Saint-Luc and further wished to go on record as stating that he always was there when we needed him. She then wished to further go on record as stating that Council will continue to be as great and as wonderful.

The resident then requested that the City intervene so that there be a *drop-in centre* in Côte Saint-Luc.

7) Sidney Benizri

The resident inquired as to when Trudeau Park would be redone to which Acting Mayor Berku responded in 2017.

8) Mitchell Kujavsky

The resident inquired as to how the process of obtaining land would occur in view of realising the Cavendish extension to which Acting Mayor Berku responded that the City of Montreal is negotiating land in order to build an underpass as the Cavendish extension won't be a straight line. The resident then inquired as to whether the City has received any pressure to object to the Cavendish extension to which Acting Mayor Berku responded in the negative.
