STATEMENT TO COMMEMORATE THE APRIL 19^{TH} , 73^{RD} ANNIVERSARY OF THE UPRISING OF THE WARSAW GHETTO

Mayor Brownstein gave a brief statement to commemorate the April 19th, 73rd anniversary of the Uprising of the Warsaw Ghetto. He then called for a moment of silence which was then held.

QUESTION PERIOD

The question period started at 8:08 p.m. and finished at 8:56 p.m. Eight (8) people asked to speak and they were heard.

1) Uli Eliah

The resident cited a potential health risk at the corner of Montgomery and Beland; specifically, a lady who currently resides at Saint-Patrick's Square has been feeding pigeons and squirrels. Councillor Berku then responded that she will follow up with the Public Safety Department in view of ascertaining what the City could possibly do. She then emphasized that (as a general principle) in order for Public Safety to properly issue a Statement of Offence for the (alleged) Infraction, it is best that a Public Safety Officer personally witness the offence.

2) Dr. Maurice Amsellem

The resident stated that the immovable located at 6803 Heywood has an issue with vehicles egressing its underground parking garage because when attempting to do so, vehicles are highly prone to an accident given the current traffic configuration coupled with the speed in which vehicles travel past the garage to which Mayor Brownstein stated that the Traffic Committee could look at the issue and ascertain whether the City needs to take any action regarding the matter.

3) Debbie Vineberg

The resident echoed the sentiments of her fellow resident (Dr. Amsellem) to which Councillor Nashen stated that, within the next few weeks, the Traffic Committee will meet to look at the issue.

4) Dr. Bernard Tonchin

The resident congratulated the newly elected Councillor, Sydney Benizri, on his most recent by-election victory.

The resident then called upon the City to look at taking proactive measures to clean Air Ducts in buildings where seniors are housed as well as to ensure that Fire Alarms are working properly to which Councillor Berku responded that the City could look in to the issue of Air Ducts.

The resident then called for an update on the status of the Cavendish Extension to which Mayor Brownstein responded that he is currently meeting with various officials to push Cavendish ahead to all various levels of government.

5) Irving Itman

The resident congratulated the newly elected Councillor, Sydney Benizri, on his most recent by-election victory. The resident then inquired regarding the Cavendish Extension; in particular, why the Quebec Government must first deem this project a priority prior to the Federal Government being able to disburse a contribution to which Mayor Brownstein stated that, for the Provincial Government, the project must have an island-wide benefit.

6) Toby Shulman

The resident called upon the City to erect a Park Bench on the East Side of Caldwell - between Kildare and Mackle — closer to the strip mall to which the Director of Public Works, Mrs. Beatrice Newman, stated that a bench has already been erected there but that she could double-check the matter.

The resident then advised council that she attends aqua-fitness classes at the City's Aquatic and Community Centre and wondered why she would have to continuously fill out the same information each year when the City should have kept it on file to which Mayor Brownstein responded that the City could indeed look in to this matter.

The resident then inquired as to which Park would be designated for special events considering the current enhancements done to Trudeau Park, to which Mayor Brownstein responded that for Canada Day, it would be the (former) Wagar High School Field but for other events; each event may be designated to occur at a separate location.

The resident called upon the City to ensure that the STM has a shuttle bus from the Cavendish Mall to the Cummings Centre and the Jewish General Hospital as well as other areas to which Councillor Berku responded that that STM is not amenable to this request but, that the City may look at alternate modes of transportation to the Hospital District.

7) David Ohana

The resident inquired as to what the process would be to acquire a City lane since he has been the one who is maintaining the one adjacent to his immovable to which Mayor Brownstein stated the policy to sell lanes is currently at the Municipal Evaluation price but that City could explore alternate proposals.

8) Mitchell Kujavsky

The resident explained that there is currently an issue with provincial legislation concerning Mobile Polling to which Mayor Brownstein stated that the immediate past Election Returning Officer, Me. Andrea Charon, has taken note of the comment.

The resident then stated that Kirwan Park is in a state of disrepair and called upon Council to make this park a priority to which Mayor Brownstein responded that some of the issues he heard when he went campaigning (for his Mayoral seat) door-to-door were indeed resolved. He then stated that the City has implemented several short-term enhancements such as: the walkway at Blossom, the addition of garbage receptacles, the transferring of benches from Trudeau Park (currently being enhanced) to Kirwan Park, painting where necessary, the installation of additional lamp posts as well as filling in any potential crevices. Mayor Brownstein then stated that a long-term overall renovation plan is also a priority for the City. Councillor Levine then added that the City should renovate Kirwan Park at a level that pleases the residents. Councillor Erdelyi then added that benches have already been installed at Kirwan Park.
