QUESTION PERIOD

The question period started at 8:08 p.m. and finished at 8:35 p.m. Four (4) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident lamented regarding the lack of attendance by members of the public at City Council Meetings and inquired as to whether there is something that could be done to encourage more members of the public to attend council meetings. Mayor Brownstein responded that he has always believed in openness; letting people speak and being open to discussion. He further explained that he believes in transparency. He then explained that members of council disseminate their (City) e-mails as well as their phone numbers for any member of the public to reach them. He also explained that in view of keeping the public informed, the City has a website and certain members of council even have a blog.

2) Tamar Hertz

The resident noticed that the Little Sunshine Programme was not listed in the City's Recreation Guide and wondered as to why it is was not indicated therein to which Mayor Brownstein responded that the City, despite all of the tremendous efforts it expended, was unable to maintain this programme in its current form. However, he explained, that the City is looking in to alternative venues to still have a programme that is functioning.

The resident expressed her disappointment that the Programme will not continue in its current form and then requested that for any future decisions on any other similar programme being offered, that the parents of the children enrolled be consulted; as she had suggested many times in the past. All members of council took note of the resident's request.

3) Brian Gilfix

The resident complained regarding the proliferation of ground hogs on Côte Saint-Luc's territory to which both Councillors Nashen and Berku responded that the City is bound by stringent provincial legislation in terms of their removal. Councillor Berku then further explained that the City does what it could for animals in the public domain; in particular, by contracting with the SPCA who would be tasked with the follow up. She then specified that residents who have issues with wild animals on their private property must deal with the matter themselves (by contracting with a licensed trapper) but even those licensed to deal with wild animals are bound by stringent provincial legislation.

4) Filomena DeSantis

The resident requested to install a fence along the same boarders and parallel to the one neighbouring her property owned by the JPPS daycare. She then spoke of individuals that trespass on her property. She then spoke of motorists not respecting the Stop Sign on her street. She then asked that her street be made a One-Way.

Mayor Brownstein then responded that the City's Urban Development Department is tasked to look in to the issue of the fence as well as possibly making her street a one-way and the Public Safety Department is tasked to look in to the issue of people on her private property without her authorization.

The resident complained of a wooden structure holding a children's pool illegally placed on City property, specifically, by the daycare neighboring her immovable. Secondly, she complained of daycare staff smoking on her property.

Mayor Brownstein stated that the City could look into her issues and get back to her with any follow up that they could potentially undertake.

WHEREAS packaging is one of the most powerful promotional vehicles for tobacco products;

WHEREAS the *Federal Tobacco Control Strategy* 2012-2017 must be renewed between now and March of 2017 and the standardization of packaging must be one of the first measures deployed within the context of an approved strategy;

WHEREAS in conformity with the recommendation of the *World Health Organization*, Australia, France, the United Kingdom and Ireland all adopted laws that demand neutral and standardized packaging for tobacco products and several other governments have also announced their intention to do so in the near future;

The appearance of the cigarettes will also be standardized; so, amongst other things, to prohibit the use of a brand, logo, colors and special finishes as well as to establish the norms on the length and diameter of the cigarettes."

RE: DROP IN CENTRE - UNDERTAKINGS BY CÔTE SAINT-LUC AND CUMMINGS CENTRE

Dear Ms Grunberg,

The City of Côte Saint-Luc ("City") is delighted that the New Horizons grant ("Grant") for the Senior Drop In Centre ("Centre") has been approved. The City is looking forward to the strategic alliance with The Cummings Centre ("Cummings") that provides a solution to the closing of the René-Cassin Seniors Drop-In Centre and Caregiver Respite program. The City has provided a new location for the Centre which will be in a designated room and bathrooms which are located in the Parks and Recreation/Aquatics and Community Centre complex ("Premises").

The initial term of the arrangement will be for three (3) years ("Term"). It is understood that the Term, contemplated to start on or about August 29th, 2016, can be reduced at any time by the Cummings due to reduced participation or lack of funding. Cummings must provide the City with at least a three (3) month notice in writing. The Centre's estimated opening hours will be from 9 am- 4 pm, five (5) days a week. As discussed, Cummings will assume the cost and responsibility for the staffing, programming, operations and management of this Centre at the Premises. Cummings will pay to the City all additional human resources expenses that they incur that are required to have the program run, including but not limited to the salaries of the Blue Collar employees, security agents and attendants as well as costs related to maintaining the Premises including but not limited to all "materials" such as electricity, toilet paper, supplies and other maintenance costs subject to the approval of the grant officer. The estimated cost of these expenses should not exceed a total amount of \$6,666.00 for the first year. All amounts claimed by the City must be justified with detailed invoices and must be approved by Cummings prior to the payment. For the following two (2) years of the Term, if the program is successful, the proposed amounts will not exceed \$12,000.00 and \$15,000.00 for each year respectively. Again the City must justify the expenses and have them approved by Cummings.

The City has also agreed to perform the necessary renovations and upgrades to the Premises, including, but not limited to, access on the main floor, the installation of a small kitchenette, storage, certain upgrades to the handicap bathroom and a ramp at the emergency exit. Cummings has allocated from the Grant an amount that should not exceed \$10,000.00 to be paid to the City for the upgrades upon pre-authorized approvals of detailed invoices at competitive prices by Cummings. Cummings has agreed to allocate a maximum of \$5,000.00 for the purchase of equipment pre-approved and requested by Cummings. These amounts will be disbursed by Cummings to the City as the funding becomes available to Cummings over the course of the first year. The City will aim to finalize the renovations and upgraded by August 1, 2016. The target date for opening the Centre is August 29, 2016.

By signing the letter Cummings hereby indemnifies, exonerates, defends and holds harmless, save and except for acts of gross negligence, the City and all affiliates, elected officials, employees, agents and representatives, volunteers of the City, from and against all direct and indirect claims, demands and damages, in capital, interest, costs of whatsoever nature and whenever arising in connection with this arrangement.

As well, without limitation, Cummings shall defend, hold harmless and indemnify the City and all affiliates, elected officials, employees, agents and representatives, volunteers of the City for any and all claims, costs, expenses and liabilities, of whatsoever nature, in connection with the arrangement, the Premises, and any other matter expressed in or implied under this arrangement.

Furthermore, Cummings shall be solely and exclusively responsible for the administration, management and all matters related to the operations of the Centre to the complete exoneration of the City in capital, interests and costs, to assume and pay the salaries of the employees running the Centre and be solely and exclusively responsible, to the complete exoneration of the City, in capital, interests and costs, for the conduct and remuneration of its employees (including, without limitation, all salaries, benefits, CSST, workmen's compensation, etc.) and all insurance premiums associated with the insurance required under this arrangement.

For the duration of the Term, Cummings shall maintain an insurance policy for damage to property and all-risks civil responsibility, the coverage limits of which will be for an amount of not less than ONE MILLION DOLLARS (\$1,000,000) per occurrence. Cummings has agreed to name the City as an additional insured on such policy with a \$0 deductible payable by the City. Cummings shall remit to the Lessor a certificate of the requested insurance policy.

Kindly indicate your agreement to all of the above by signing in the space provided hereinbelow, at which point we shall have a mutually binding agreement. Kindly scan back your signed letter agreement as soon as possible. Your scanned signature and emailed document shall be deemed an original and together with this Letter Agreement

signed by the undersigned, shall form one, the same, and the entire agreement of the parties, which the parties have agreed to draft in English (que les parties ont consenties à rédiger en anglais).
