MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, SEPTEMBER 12, 2016, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

PRESENTATION OF THE IRWIN COTLER AWARDS

Mayor Brownstein expressed that last year, the City Council had decided that the City would be presenting the Irwin Cotler award to a high school and elementary student who best exemplifies the traits that Irwin Cotler teaches which includes community service, *Tikun Olam*, and working for the betterment of human rights.

Two awards were presented by Member of Parliament, Anthony Housefather.

The high school recipient was Ms. Madison Gold of Bialik high school who has successfully acted as an ambassador for her school as well as for organizations such as NCSY, Friendship Circle and the Diller Teen Fellows Programme.

The elementary school recipient was Ms. Gabriel Murray of L'École des Amis du Monde for her work and fundraising initiatives for the *Hashima* program in Kenya which is an organization which aids girl refugees between the ages of 13-23 providing them with assistance such as safety, shelter and legal programs. Her principal graciously accepted the award on her behalf.

QUESTION PERIOD

The question period started at 8:05 p.m. and finished at 9:35 p.m. Thirteen (13) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident referred to a recent newspaper article published in the Suburban stating that no culprit had been found in the case involving a woman who was attacked in her garage approximately one year ago. The resident inquired as to what was being done by the Police concerning the case to which Mayor Brownstein responded this was a police matter and referred the resident to

Station 9 Commander, Jean O'Malley, who was present at tonight's Public Council Meeting.

2) Mélodie Cohn

The resident applauded Ms. Gabrielle Murray from the school Les amis du Monde, for the Irwin Cotler award she received.

The resident lamented regarding cuts in the programming to children under the age of 5, to which Mayor Brownstein responded that there has indeed been increased programming for that age group which includes "Mom and Tot playtime" and "Mom and tot Swimming".

The resident then complained that the City should not cut its Little Sunshine Program because additional marketing should have been used to counter the low enrollment in the program to which Mayor Brownstein responded that there was simply no market for the program despite significant marketing efforts expended by the City.

3) Tamar Hertz

The resident requested that Council allow the Little Sunshine Program to continue to run "as is" for one more year to which Mayor Brownstein responded that the Parks and Recreation personnel had already expended many hours on the program and cannot afford to expend any more efforts. Mayor Brownstein then stated that the City would like for a third party, in the private sector, to come forward in order to continue to run the program as the City does not oppose continuing the program; just not in its current format.

4) Charles Guérin

The resident encouraged Council to continue the Little Sunshine Program to which Mayor Brownstein responded that too few children were enrolled for the programme to be successful as only 3-5 participants are currently enrolled in the program. Mayor Brownstein then added that many efforts had already been expended to increase the enrollment; however the program is not in demand in the community as other programs are already available elsewhere.

5) Dr. Davina Mill

The resident requested to continue the Little Sunshine Program. The resident then complained about the lack of advertising of the program at the Winter Carnival, at the open house and within the Parks and Recreation brochure to which Mayor Brownstein responded that the Little Sunshine Program had been in the Parks and Recreation brochure with the exception of this year's brochure and that that he is looking at other options so that the program can continue but not as a City-run program.

6) Toby Shulman

The resident complained concerning potholes on the South East side of Cavendish Boulevard and Kildare Road to which Mayor Brownstein responded that the Public Works Department could look into the matter.

The resident then expressed her gratitude that the pavement in the City Hall parking lot as well as the curb at the intersection of Fleet Road and Cavendish Boulevard had both been repaired. However, the resident complained that there was a lack of lighting in the area where the Fleet Road and Cavendish Boulevard intersection had been repaired to which the Mayor responded that he was unaware of the issue but would request that staff look in to it.

7) Irving Itman

The resident expressed his appreciation for the new chairs in the Council room. The resident then complained regarding the volume of traffic on Côte Saint-Luc Road, at the corner of Côte Saint-Luc Road and St-Ignatius Avenue and suggested the traffic light at the intersection be covered to which Mayor Brownstein responded that a Public Security officer has already been dispatched to help with the traffic outside of school hours.

The resident then complained about the street lights not functioning along Cavendish Boulevard to which Mayor Brownstein responded that Hydro Quebec must perform certain repairs to render the street lights functional.

The Resident complained that the waterfall and fountain at Yitzak Rabin Park was not functioning and that a body of running water is required to celebrate *Tashlich* to which Mayor Brownstein responded that Public Works will attempt to repair the fountain (if possible). The resident then informed Council that, on July 24, 2016, at 10 pm, he called Public Security to report a worrisome situation but the dispatcher he spoke with refused to send an officer and would like an explanation as to why no officer was dispatched to which Mayor Brownstein referred the resident to Jordy Reichson, Director of the Public Safety Department, in order to investigate.

8) Lili Yesovitch

The resident complained that the City should continue the Little Sunshine program despite its budgetary concerns to which Mayor Brownstein responded that it is not a question of budget alone; it is also a question of *numbers*, that there is no demand for this program and that the City has many other successful programs for young children.

9) Joseph Douek

The resident stated that he has recently purchased a residence in the City and that upon the purchase of the residence he was informed that the shed located in his rear yard which borders a City street was actually on the City's property. The Resident then expressed to Council that moving the said shed would be at a great expense and trouble to him. Mayor Brownstein responded that Council took note of his concerns and that they would discuss the file as soon as possible.

10) Mary-Joy Klein

The resident expressed her concern with the traffic build-up at the intersection of Côte Saint-Luc Road and St-Ignatius Avenue and suggested that the City cover the light at that intersection (during construction) to allow for a freer flow of traffic. The resident further requested that the City coordinate with the City of Montreal in order for traffic to run more smoothly at the aforementioned intersection to which Mayor Brownstein responded that the City will follow up on the resident's request.

11) Andrew Siviatowsky

The resident inquired as to whether or not a wind, sun or traffic study had been commissioned by the City with regards to the proposal being put forward for the construction of housing on Caldwell Avenue to which Mayor Brownstein responded that the Developer was at the first proposal stage at the present time and that nothing further has yet advanced.

12) David Baker

The resident complained regarding the construction project proposed on Caldwell Avenue to which Mayor Brownstein responded that the builder nevertheless is allowed to build if his project is in conformity with the City's By-laws.

13) Dr. Roger Fenster

The resident expressed concerns that the proposal to build the housing project on Caldwell Avenue may cast a shadow on his property thus affecting his quality of life to which Mayor Brownstein responded that he will take note of the resident's concerns.
