# MOMENT OF SILENCE DUE TO UNFORTUNE PASSING AWAY OF HAROLD GREENSPON AND JOE RAY

Mayor Brownstein held a moment of silence due to the unfortunate passing away of former Côte Saint-Luc Councillor Harold Greenspon and Côte Saint-Luc volunteer, Joe Rae.

# SPECIAL ANNOUNCEMENT - PIERRE BRUNET MCDONALD'S PARKS AND RECREATION BURSARY PROGRAM - COUNCILLOR MIKE COHEN

Councillor Cohen announced a special bursary programme wherein on Wednesday, May 3<sup>rd</sup>, McHappy Day, money is raised for different charities. In Côte Saint-Luc, Councillor Mike Cohen stated there would be a "Pierre Brunet McDonalds Parks and Recreation Bursary Programme" where moneys generated at the Quartier Cavendish and Côte Saint-Luc Shopping Centre locations will be used so that eligible participants can register in Côte Saint-Luc Parks and Recreation Programmes; even if they are unable to afford them.

A commemorative photo was then taken with Council and Mr. Brunet.

# **QUESTION PERIOD**

The question period started at 8:32 p.m. and finished at 9:09 p.m. Five (5) people asked to speak and they were heard.

# 1) Toby Shulman

The resident complained regarding a lack of police presence in Côte Saint-Luc. Councillor Nashen then clarified that the SPVM is an agglomeration (vs. local)

service. He then explained that both Mayor Brownstein and Director Reichson both meet routinely with the local police Commander.

The resident then suggested that Director Levine video some of the great Library programmes held during the winter so that those absent for the winter can see the videos of these programmes to which Mayor Brownstein stated that this was a valid suggestion that the City could look into.

# 2) Emanuel Darmond

The local business owner inquired as to the logistics and details of the R.E.C. room agreement with the City of Côte Saint-Luc to which Mayor Brownstein and Councillor Berku both responded and then referred the questioner to Me. Charon of the City's purchasing department, in the audience tonight, for further details.

Mayor Brownstein then instructed the City Clerk to insert the following statement in to the public record:

"This issue was being discussed for many meetings and was in the Suburban many times and it was public record that we were looking for various options; particularly for children's programming, six (6) and under."

# 3) Mélodie Kahn

The resident wished to discuss the traffic lights - one on Cavendish and Kildare and one on Kellert - more specifically, the length of time it takes for the traffic lights to change from red to green and amount of time allotted for pedestrians to cross.

Councillor Nashen then responded that absolute priority regarding the traffic lights is pedestrian safety and that the response from many of the officials reviewing the recent changes regarding the Cavendish and Kildare intersection is that there have been even greater improvements to that intersection in terms of pedestrian safety. Councillor Nashen also explained that there is a crossing guard at that intersection.

# 4) Miki Harrar

The resident inquired as to how many tax exempt synagogues there are in Côte Saint-Luc to which Councillor Erdelyi responded.

The resident then asked for more particulars and information regarding the tax exemptions to which Mayor Brownstein responded with the information he had and, for information which he did not have; whatever can be provided legally will be provided. Councillor Erdelyi then added that EVALWEB provides certain information which may respond to the resident's queries.

# 5) Mike Cuplowsky

The resident raised the lack of parking as well as the issue of pedestrian safety on Marc Chagall based on the saturation of traffic from Bialik, Chabad, the trucks going to and from the snow dump and the cars associated with the tenants who will be eventually living in the new construction that will soon be ongoing. Councillor Nashen then responded that currently, the only place the City placed a pedestrian crosswalk is in the middle of the block is in front of La Marquise as that is where there are pedestrians that need to cross the street. In addition, the yellow, "no parking" area was in order to increase the visibility of the motorists towards the crosswalks. Councillor Nashen then explained that with new buildings being erected, the City will have to review traffic and pedestrian safety and verify what (if anything) may be necessary to modify.

The resident then complained regarding the specific situation of traffic during the drop-off period for Bialik High School for which Councillor Nashen explained that the situation is well-managed, that the situation is well-controlled as Public Security is on location many mornings a week to ensure traffic-flow, adequate parking and pedestrian safety at that corner. As well, he explained, the City takes the matter very seriously.
