MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, OCTOBER 2, 2017, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

Mayor Brownstein began by thanking the City's Staff and Directors as well as the City Councillors for their great work.

Mayor Brownstein then welcomed and thanked Commander Jean O'Malley for keeping the City safe.

Mayor Brownstein then requested a moment of silence for the recent tragic events in Edmonton and Las Vegas.

Mayor Brownstein then presented a video regarding the City's EMS Department while he went on a ride-along.

QUESTION PERIOD

The question period started at 8:10 p.m. and finished at 9:05 p.m. Nine (9) people asked to speak and they were heard.

1) Sharon Freedman

The resident began by wishing everyone a Happy (Jewish) New Year.

The resident then expressed her appreciation to the Côte Saint-Luc City Council for their support regarding the drop-in centre for seniors located at the Aquatic and Community Centre. The resident then complained, however, that seniors can only go a certain amount of times per week at the drop-in centre due to the lack of space.

The resident then proposed to open a Sunday Programme for vulnerable elders in Côte Saint-Luc. Mayor Brownstein responded that the drop-in centre for seniors opened following the receipt of a grant and in order to expand this program, the City will need more funding. Mayor Brownstein then specified that space is not an issue since the room is available on Sundays.

2) Toby Shulman

The resident began by wishing everyone a Happy (Jewish) New Year.

The resident then complained about the traffic on Cavendish and requested to have two left turn lanes on Cavendish to turn onto Kildare in order to improve the traffic flow. Councillor Nashen mentioned that this proposal was studied by traffic experts and outside consultants and according to them, having two left turn lanes would actually produce the adverse effect of increasing traffic. Councillor Nashen then specified that the current traffic configuration was proposed by traffic consultants and it is the best configuration possible without undertaking major construction work.

The resident then complained that speed limits are not always respected and that some residents do not respect stop signs. The resident then requested that the police and Public Security should issue more Statements of Offence. Mayor Brownstein responded that the City is currently looking in to expanding the area of the 30 km/h speed limit zones around schools and parks. Mayor Brownstein then specified that a Public Consultation will be held regarding this matter. Mayor Brownstein then added that the City will ensure police enforcement, more precisely, speed limit enforcement.

The resident then requested to add temporary lighting for the City Hall and Library parking lot to which Mayor Brownstein stated the City could look into it.

3) Mark Cohen

The resident complained about an oversaturation of traffic on Glencrest and then inquired if it is possible to add a sign prohibiting right turns off of Cavendish and onto Baily during rush hour to reduce traffic on Glencrest. Councillor Berku mentioned that she is working on this matter with the Engineering Department. Councillor Berku then added that a pilot project could prohibit drivers to turn right off of Cavendish and onto Baily between 4:00 p.m. and 6:00 p.m. Councillor Berku then added that a letter will be sent out to the residents to inform them of this pilot project.

4) Carol Meindl

The resident expressed her satisfaction with the City's suggestion to add a sign prohibiting right turns off of Cavendish and onto Baily between 4:00 p.m. and 6:00 p.m. The resident then inquired if it is possible to have this prohibition begin at 3:30 p.m. instead of 4:00 p.m. Councillor Berku responded that she would discuss this request with the Engineering Department.

5) Norman Sabin

The resident complained that drivers on Cavendish must wait for a long period of time in order to allow drivers to turn left off of The Avenue, Mackle or Kildare and onto Cavendish, when most of the time, drivers are not even turning left onto Cavendish. The resident then wanted to know if the City has left turn lane traffic sensors on streets such as The Avenue, Mackle and Kildare to which Mayor Brownstein responded that it is a very good idea to have left turn lane traffic sensors and then added that the Urban Planning Department will look in to it. Councillor Erdelyi then mentioned that some traffic sensors are not functioning

very well and the City is looking in to the idea of replacing these sensors. Councillor Kovac then specified that traffic related issues and infrastructure concerning Cavendish, around Kildare, Mackle and The Avenue, will be reviewed by the City's Engineering Department.

6) Charlotte Amiga-Benzwy

The resident began by wishing everyone a Happy (Jewish) New Year.

The resident sought an update on the lighting in Kirwan Park. Councillor Allan J. Levine responded that the City will hold a Public Consultation on the subject of renovations (in general) to Kirwan Park. Beatrice Newman, Director of Public Works, then mentioned that the City is planning on placing five new lampposts in Kirwan Park. Mayor Brownstein then added that Kirwan Park is the next major park to be renovated and that the Public Consultation for this park will be held on December 3, 2017.

The resident mentioned that two or three copies of the press release regarding the Public Consultation on Kirwan Park was posted on Blossom Street and then complained that this press release should be delivered to all the residents. Councillor Allan J. Levine responded that he publicized the press release to residents in order to inform them of the upcoming Public Consultation. Mayor Brownstein then clarified that when the Public Consultation will occur, the City will ensure that the residents are all adequately aware of it. Mayor Brownstein then cordially invited the resident to participate at the Public Consultation.

7) Ms. Krief

The resident complained about the traffic configuration which causes Glencrest Avenue to become a thoroughfare. The resident then tabled a petition entitled "Friendly Glencrest Neighbours" in which the undersigned residents of Glencrest request that "the City respects their traffic concerns fairly and in the same manners as neighbouring streets and mandates an independent engineering firm to conduct a traffic study of District 3". Mayor Brownstein responded that it was never the City's intention to make Glencrest a thoroughfare and reminded the resident of the City's pilot project previously announced which consists of prohibiting right hand turns off of Cavendish and onto Baily between 4:00 p.m. and 6:00 p.m. thus alleviating traffic off of Glencrest. Councillor Berku then added that the City examined different options and the above-mentioned pilot project is the optimum, least consequential option.

8) Rabbi Yehuda Benoliel

The resident complained that he is still waiting on an answer regarding his request to obtain a parcel of land from the City. Mayor Brownstein responded that the City is examining his request.

The resident then requested to add a speed bump on Eldridge, between Kildare and Guelph to which Mayor Brownstein responded that Urban Planning will look in to this query.

9) Miki Harrar

The resident complained that when he came to City Hall, he was unable to obtain a copy of the documents related to his access to information request pertaining to tax exemption properties in Côte Saint-Luc as he waited for 25 minutes, lost

patience and then left. The resident then requested that a copy of the documents be mailed to him to which Jonathan Shecter responded that the City will mail the resident a copy of the documents.

The resident then inquired as to how can his request for review before the Access to Information Commission be dealt with more quickly to which Jonathan Shecter explained the process, more particularly, that when an application for review is made, the Access to Information Commission will schedule a mediation between the resident and the City and that they are responsible for the timing of this scheduling; therefore, the City having no powers to hasten the process.

Councillor Erdelyi then clarified that the City received a high volume of access to information requests this year and which, unfortunately, has limited resources to expedite their processing.
