MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, DECEMBER 11, 2017, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

Mayor Brownstein began by giving a certificate to Dr. Bernard Tonchin to highlight the resident's 90th birthday as well as his participation at the City of Côte Saint-Luc's Council Meetings for numerous years.

QUESTION PERIOD

The question period started at 8:09 p.m. and finished at 8:30 p.m. Four (4) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident began by thanking the members of the Côte Saint-Luc City Council for recognizing his 90th birthday.

The resident then went on record by stating that the City of Côte Saint-Luc is a proud, bilingual City that allows its residents to express themselves in both English and in French.

Mayor Brownstein thanked the resident and gave the resident his best wishes for his 90th birthday.

2) Toby Shulman

The resident expressed her satisfaction with having a City Park named after Elie Wiesel, but complained that the park is small and poorly located and thus proposed its relocation. Mayor Brownstein responded that the City wished to have Elie Wiesel Park located at the busiest corner of the City of Côte Saint-Luc for it to be visible to all. Mayor Brownstein then added that the City is looking into incorporating a museum into the Elie Wiesel Park.

The resident then sought an update regarding organic waste collection in multifamily dwellings. Councillor Erdelyi responded that according to the City of Côte Saint-Luc's By-Law, newly constructed buildings are required to have a three-way chute to allow residents to dispose of organic waste, recyclable materials and garbage. Councillor Erdelyi then added that he continuously works with the City's Public Works Department to improve the City's recycling and organic waste programs. Mayor Brownstein then cordially invited the resident to contact the City Manager for further details.

The resident then complained that the Library and City Hall parking lot does not have parking spaces reserved for young families as it previously did to which Mayor Brownstein mentioned that the family parking signs will be reinstalled soon.

The resident then proposed to have signs indicating that the Library and City Hall parking lot is exclusively for the users of the Library and the City Hall to avoid having residents living on Sir Walter Scott Avenue park in the Library and City Hall parking lot.

The resident then inquired as to the success of the City's programs for children and adults to which Mayor Brownstein cordially invited the resident to contact the City Manager for further details.

3) Charles Guerin

The resident inquired if the City's 2018 operational budget will be allocating an amount for the development of a more transparent and more open City. Councillor Berku responded that the City will hire a data wrangler in 2018 in order to have information easily accessible to the public prior to and subsequent to Council Meetings. Councillor Erdelyi then added that the 2018 budget will be adopted on January 22nd and the Three-Year Capital Expenditure Programme will be adopted on December 18th.

The resident then inquired if the Côte Saint-Luc City Council has any objections to stream the Council Meetings live. Councillor Berku mentioned that the audio recordings from Council Meetings will be available the day following the Council Meeting. Councillor Berku then added that the City will not (for the moment) video live-stream the Council Meetings with "Facebook Live" as the quality of those recordings are not pristine.

4) Mary-Joy Klein

The resident inquired if there is a senior discount for the City's adult art classes to which Mayor Brownstein referred the resident to discuss the matter with the Director of Parks and Recreation, Cornelia Ziga.

5) Dr. Bernard Tonchin

The resident proposed to have the S.P.V.M. increase its presence in the City to which Mayor Brownstein responded that the City Staff will look into it.

The resident then sought an update on his proposal given at a previous Council Meeting to have all City street lights turn red simultaneously at intersections to allow pedestrians to cross safely. Mayor Brownstein cordially invited the resident to discuss this matter with the Director of Urban Development, Charles Senekal.

The resident then sought an update regarding the Cavendish Extension to which Mayor Brownstein responded that he will be meeting (Borough) Mayor Montgomery to discuss this matter and is looking into having a meeting with (City of Montreal) Mayor Plante.

The resident expressed her concern as to having dogs walk through the play area and splash pad located in the Richard Schwartz Park when walking to and back from the nearby Dog Park. Councillor Erdelyi responded that there is a sign prohibiting dogs in the play area. Councillor Erdelyi then added that the City will look into this matter.

The resident then went on record as wanting her questions answered during the Council Meeting Question Period, immediately after they are asked. Mayor Brownstein responded that the Côte Saint-Luc City Council is looking into ways to provide the right information to its residents.

4) Dr. Bernard Tonchin

The resident complained that black park benches get really hot in the summer due to the colour black attracting heat. Councillor Erdelyi responded that the benches in the Dog Park are green, thus not having this same effect.
