MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, FEBRUARY 12, 2018, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

Mayor Brownstein briefly explained the rules related to Question Period. Mayor Brownstein specified that in order to be as efficient as possible, each resident has three (3) minutes to ask one question as well as one follow-up question. Mayor Brownstein then added that residents who wish to discuss matters extensively can meet either Mayor Brownstein or City Manager Abramovitch.

QUESTION PERIOD

The question period started at 8:06 p.m. and finished at 8:25 p.m. Four (4) people asked to speak and they were heard.

1) Charles Guerin

The resident sought information on the City's proposal related to the upcoming Smart Cities Challenge (a pan-Canadian competition that encourages communities to improve the lives of their residents through innovation, data and connected technology). Mayor Brownstein began by thanking the resident for his hard work in relation to this competition. Mayor Brownstein then added that the City is definitely looking into it and will continue to work with its residents in order to submit a proposal that can help the City win \$10M or \$50M.

2) Irving Itman

The resident sought additional information on the discussions Councillor Berku had with the STM in relation to having a bus route connect the City of Côte Saint-Luc to the Hospital District. Councillor Berku responded that the City indeed met with the STM representatives and requested that the STM offer a bus route traveling towards the Hospital District. Councillor Berku then added that the STM refused the City's request because buses cannot cross Decarie Boulevard due to the heavy traffic. Councillor Berku then mentioned that the City will meet with the STM again; once the STM completes their current study.

3) Lili Yesovitch

The resident began by thanking City Manager Abramovitch for her wonderful work.

The resident expressed her concern that the City does not seem to have figures "at their fingertips" related to the ACC. Mayor Brownstein clarified that the City has many statistics related to the ACC and is looking into having additional statistics available to the public, in the light of having a more open government. Mayor Brownstein then added that the City's statistics are often comprised of either different revenues or different expenditure, preventing the City from having the exact detailed breakdown the resident is requesting. Mayor Brownstein then invited the City Councillors to highlight some figures when presenting the monthly departmental reports.

4) Andre Zoldan

The resident began by thanking City Manager Abramovitch and Councillor Sebag for their kind replies to his e-mails.

The resident sought information on the excavation work at the corner of David Lewis and Clanranald and inquired about the zoning regulations concerning that specific corner. Charles Senekal, Director of Urban Development, responded that the corner of David Lewis and Clanranald is a residential zone that allows for twelve-storey residential buildings. He then added that the City has not yet received an official proposal to build an immovable there.

The resident then complained about having restrictive left turn lanes on Cavendish Boulevard to turn onto The Avenue and Mackle. Mayor Brownstein responded that this matter must be discussed with the City's Engineering Department.

The resident then sought an update on the Cavendish Extension. Mayor Brownstein responded that Mayor of Montreal, Valérie Plante, informed him that the person responsible for the Cavendish Extension project, Councillor Caldwell, will have a meeting with the affected municipalities in order to give them an update on the project.

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the Mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the Mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance;

WHEREAS agglomeration council meetings may be held in March 2018 for which members of the municipal council shall establish the stance that it wishes to take;

"THAT Council take the following stance in view of any Agglomeration Council meetings to be held in March 2018 as follows:

ADOPTION OF AN AGREEMENT WITH URGENCES-SANTÉ

WHEREAS the *Act respecting pre-hospital emergency services* requires a municipality to enter into an agreement with a Regional Health Board for the provision of first responder services;

WHEREAS the Act respecting the exercise of certain municipal powers in certain urban agglomerations gives the City of Côte Saint-Luc ("City") exclusive jurisdiction over first responder service on its territory;

WHEREAS for the territory of the islands of Montreal and Laval, the *Corporation d'Urgences-santé* acts as a Regional Health Board for pre-hospital services;

WHEREAS it is expedient for the City to update its existing agreement in order to improve the Emergency Medical Services division;

It was

MOVED BY COUNCILLOR OREN SEBAG SECONDED BY COUNCILLOR RUTH KOVAC

AND RESOLVED:

"THAT the Côte Saint-Luc City Council (''Council'') hereby authorizes the City to enter into an agreement with the *Corporation d'Urgences-santé* entitled "*Protocole d'entente entre la Corporation d'Urgences-santé et la Ville de Côte Saint-Luc pour son service de premiers répondants*" ("Agreement") consisting of ten (10) pages plus three (3) annexes;

THAT Council further authorizes any of: the City Manager, the Associate City Manager, the General Counsel or the Director of Public Safety to sign the Agreement that gives effect to the foregoing." CARRIED UNANIMOUSLY

SECOND QUESTION PERIOD

The second question period started at 9:33 p.m. and finished at 9:42 p.m. Two (2) people asked to speak and they were heard.

1) Charles Guerin

The resident inquired if the loans from the various loan by-laws adopted at tonight's Council Meeting will be added to the City's existing debt. Councillor Erdelyi responded that for the past few years, the City of Côte Saint-Luc has actually been reducing its debt when borrowing money. Councillor Erdelyi then added that some loan by-laws will be reimbursed from the TECQ grant so that the actual amount of debt will not be increased.

The resident then questioned whether indicating the amount of the loan in the City's by-law will show the companies who are submitting a tender the amount that the City is willing to disburse for its infrastructure projects. Mayor Brownstein responded that prior to the adoption of the loan by-laws, the City mandates professionals to ensure that the estimates for the City's infrastructure projects are accurate. Mayor Brownstein then added that in order to be awarded the contract, one must submit the lowest conforming bid. Mayor Brownstein then added that the bids are often below the amounts indicated in the City's loan by-laws.

2) Eric Banon

The resident inquired the location of the LED street lights that will be purchased and installed in the City of Côte Saint-Luc. Councillor Erdelyi responded that the LED street lights will be installed throughout the City.

The resident then inquired if the City has a report indicating the City's expenses related to electricity as well as a report assessing the amount that the City will save by installing LED street lights. Councillor Erdelyi added that the City vet its expenses related to electricity and looked at the viability of LED lights by meeting with Hydro-Québec representatives. He then added that Hydro-Québec representatives confirmed that by installing LED street lights, the City will definitely save money.
