Mayor Brownstein began by requesting a moment of silence for the sudden passing of City employee Lucian (Luc) Cassels. Mr. Cassels was employed with the City of Côte Saint-Luc for over twenty (20) years and was the City's first recipient of the Exceptional Service Initiative, awarded to City employees for their incredible work.

HONOURING OF MR. KIMMEL AND COMMANDER O'MALLEY

Mayor Brownstein presented a certificate of appreciation to Earl A. Kimmel for more than 50 years of dedicated service to the City of Côte Saint-Luc.

Councillor Kovac then thanked Mr. Kimmel for bringing his knowledge and input to the City's Planning Advisory Committee.

Mayor Brownstein then presented a certificate of appreciation to S.P.V.M. Police Commander Jean O'Malley for having *kept the City of Côte Saint-Luc safe* and then wished him the best of luck in his future endeavours.

QUESTION PERIOD

The question period started at 8:16 p.m. and finished at 8:30 p.m. Four (4) people asked to speak and they were heard.

1) Randy Mendel

The resident requested the City to modify its building by-law in order to limit resident ownership of sewer pipes to the property line. Mayor Brownstein responded that the City of Côte Saint-Luc has recently discussed this matter and will continue to study this matter; once the Court renders a judgement regarding the Proceedings instituted against the City as a result of a blocked private sewer

pipe (located beyond the resident's property line); the costs of which the resident's insurer may be compelled to assume.

2) Phil Troy

The resident requested the City of Côte Saint-Luc's input in relation to the resident's issues with his Condo Association. Mayor Brownstein responded that municipalities do not have jurisdiction to enforce a private matter regarding the regulations concerning the management of condominiums. Mayor Brownstein then invited the resident to contact an attorney to obtain information on any legal remedies sought related to this private dispute. Councillor Berku then added that a municipality cannot implement the rules concerning the management of condominiums set forth in the *Civil Code of Quebec* since this is a purely private issue.

3) Tamar Hertz

The resident inquired when the City of Côte Saint-Luc's financial statements for the 2017 fiscal year will be filed and then published on the City's website. Councillor Erdelyi responded that based on last year's filing date, the audited financial statement for the 2017 fiscal year should (approximately) be tabled at a Public Council Meeting held in June 2018. Jonathan Shecter then added that the financial statement for the 2017 fiscal year will be tabled at the Public Council Meeting held in the next couple of months (during the May/June time period).

The resident then sought information on the progress towards releasing a more detailed budget, as she previously had requested. Councillor Erdelyi responded that the 2018 Operating Budget is more detailed than the previous operating budgets. Councillor Erdelyi then added that the City of Côte Saint-Luc is looking into providing even more information to the public, in the light of having an even more transparent government. Councillor Erdelyi then mentioned that some information cannot be revealed for confidentiality purposes.

4) Rhoda Albert

The resident complained about the signs prohibiting vehicles to park for more than two (2) hours, near the construction site on Marc Chagall. Mayor Brownstein responded that the City of Côte Saint-Luc is trying to minimize the inconvenience for the residents as well as for their visitors. Councillor Cohen mentioned that he is working with City Staff to implement a plan to alleviate the parking issues around the construction site on Marc Chagall.
