MOTION TO RECOGNIZE THE SPANISH AND PORTUGUESE SYNAGOGUE ON THE OCCASION OF ITS 250th ANNIVERSARY

WHEREAS the Spanish and Portuguese Synagogue of Montreal is the oldest Jewish congregation in Canada dating back to 1768;

WHEREAS this year the congregation is celebrating its 250th anniversary:

WHEREAS its original founders of Sephardic descent came from England, the history of the synagogue first known as Shearith Israel, reflects the various waves of migration that constitute Jewish Montreal;

WHEREAS today this synagogue has evolved into one of the most diverse congregations on the island of Montreal, regrouping Jews of Ashkenazi and Sephardic descent with origins in Spain and Portugal and Great Britain, Iran, Iraq, Lebanon, Egypt, Morocco, Algeria and Tunisia, as well as those with origins in northern, western and eastern Europe;

WHEREAS this congregation of 800 families practicing different traditions under the same roof, is a microcosm of Canadian multiculturalism and harmony in diversity and is a symbol of inclusion and positive intercommunity relations;

WHEREAS the Spanish and Portuguese Synagogue has contributed to the wellbeing of the Montreal Jewish community through the creation of the Baron de Hirsch Institute -- now Ometz -- which has provided social services to the community since 1890;

WHEREAS many residents of Côte Saint-Luc have historical ties to this synagogue;

WHEREAS the City of Côte Saint-Luc would like to recognize the synagogue's proud history and join in celebrating this milestone;

QUESTION PERIOD

The question period started at 8:37 p.m. and finished at 9:07 p.m. Ten (10) people asked to speak and they were heard.

1) Jonathan Goldman

The resident, Chairman of the Dog Committee, went on record as supporting By-Law to be entitled: "By-Law 2508 to regulate dogs" which will be adopted at a further Council Meeting.

2) Me Lionel Rossdeutscher

The resident sought an update regarding the issue that was raised at the last Council Meeting concerning the STM buses that park (without turning off their engines) at the corner of Westminster and Kildare. Councillor Berku responded that the City will be meeting with the STM on May 29, 2018 to discuss this matter.

3) Isabelle Pinsky

The resident proposed to implement additional traffic safety measures at the corner of Mackle and Armstrong. Mayor Brownstein responded that this matter will be discussed during the upcoming Traffic Committee Meeting.

4) Sean Erratt

The resident expressed his discontent with the changes to the location of the entrance to the underground parking for the multifamily dwelling being built on Parkhaven since he was of the understanding that said location would not be next to his immovable. Mayor Brownstein responded that the Director of Urban Development, Charles Senekal, will follow up on this matter.

5) Mike D'Alessandro

The resident complained that the Builder undertaking the construction of a multifamily dwelling on Parkhaven is damaging the neighbouring properties and is failing to repair them. Mayor Brownstein responded that the City instituted legal proceedings in order to resolve outstanding issues with the Builder. Mayor Brownstein then added that the City is following up with the Builder to ensure that they comply with the applicable by-laws.

The resident then expressed concern with electrical wires touching his neighbour's clothesline pole. Mayor Brownstein responded that the City will inspect this issue.

6) Eyal Gamliel

The resident requested to obtain more information on Hydro-Québec's project to be conducted in his District. Mayor Brownstein invited the resident to speak with City Manager Abramovitch since she is the staff lead person working with Hydro-Québec on this project. City Manager Abramovitch then added that she would gladly meet the resident to answer his concerns related to Hydro-Québec's project.

7) Carina Marcovitz Katz

The resident complained that she is not receiving adequate snow removal as a result of having her neighbour's vehicles parked on the street, in front of her property. Mayor Brownstein responded that Public Security will ensure that the resident's neighbour only has overnight parking permits where she meets the requirements pursuant to the City's by-laws and then added that the City will act accordingly.

8) Moshe Ingber

The resident complained that he must now incur fees in order to play pickleball at the City's Aquatic and Community Centre. Mayor Brownstein responded that he will discuss this matter with the Director of Parks and Recreation in order to try to ascertain what, if anything, could be done.

9) Iona Hassoun

The resident explained that a vehicle recently drove through a private fence and onto her property. The resident requested that the City take the necessary steps to ensure that proper barriers are erected to prevent incidents of this nature to happen again. Mayor Brownstein responded that the City is currently looking into her request regarding the private dispute she has with her neighbour.
