MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, APRIL 10, 2006, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

PRESENTATION - PROMOTION OF ANTHONY TSAKON - PUBLIC SECURITY

Mayor Housefather and Councillor Nashen presented Lieutenant Tsakon with his stripes and congratulated him on his promotion to Public Security Lieutenant.

QUESTION PERIOD

The question period started at 8:15 p.m. and finished at 8:45 p.m. Seven (7) people asked to speak and they were heard.

1) <u>Lucy Ravinsky:</u>

The resident explained that about six months ago, she, along with Yossi Milo had an idea to put together a programme called, "musicians of the world". She further explained that Councillor Berku was instrumental in realizing the idea and as a result of her efforts the event had received sponsorship from the City of Montreal and the Borough of Côte Saint-Luc / Hampstead / Montreal West as well as positive media coverage. Mayor Housefather then responded that he too concurs that Councillor Berku's efforts were laudable.

Councillor Berku then explained to the public that the "Musicians of the World" will be playing on May 11th, June 7th and July 1st, that the public should make every effort to attend and that staff members David Taveroff and Harold Cammy have also been most cooperative. Councillor Levine then explained to the public that "musicians of the world" is a "world class event".

2) <u>Avrum Shtern</u>:

The resident had the following questions:

Could the City of Côte Saint-Luc erect a similar sign as the one in Sheraton Park in Montreal West which discourages the public from buying homes pursuant to any potential Meadowbrook development?

Since a Saudi Prince has recently purchased the Meadowbrook land, could the City invite him to see the land in view of discouraging him from developing Meadowbrook?

Can the City of Côte Saint-Luc commit as part of their mill rate tax base, monies for green lands, similar to the City of Sarasota?

The resident then pointed out a recent Supreme Court decision involving the City of Vancouver and regarding zoning and land-use policy to which all members of Council took note.

Mayor Housefather then responded that the Agglomeration Council has put forward a proposal to take a loan of 15 million dollars at its next meeting for which he, Mayor Benedetti and Councillor Berku all drafted a proposal that some of these monies be used for the Angelwoods land. He then explained that it is an important future goal to see the Agglomeration Council commit monies towards Meadowbrook.

Mayor Housefather then explained that Councillors Cohen and Councillor Berku could consider the resident's recommendation to meet the Saudi Prince.

Mayor Housefather then explained that he was unaware of the particular sign in Montreal West to which the resident referred.

3) <u>Larry Boretsky</u>:

The resident wished to speak with Councillor Goldbloom to which Mayor Housefather responded that this would be possible after the meeting.

4) Alex Davis:

The resident complained that one of his fellow residents is operating a commerce from his dwelling which engenders nuisances such as trucks coming and going as well as trucks parked in front of people's houses. He then enquired as to whether this individual had all the proper municipal permits to perform the above-described actions.

Mayor Housefather explained to the resident that it was best for him to always advise Council via telephone or e-mail should a problem arise as it is more expedient than waiting until up to one month later at a Council Meeting to resolve an issue. He then called upon the resident to furnish the name and address of the individual to the City Clerk so that he may follow up on the resident's complaint.

5) Dr. Bernard Tonchin:

The resident wished to compliment Mayor Housefather on a democratically run Meeting as he opined, that, "we are now getting our answers which we didn't get before." He then explained to Mayor Housefather that, in his personal view, Agglomeration Council Meetings are likened to a 'circus'. He then called upon all members of Council to be proactive in attending Agglomeration Council Meetings.

Mayor Housefather then explained to the public that he agrees with the resident that the Agglomeration Council Meetings are undemocratic. He further explained that he personally put forward thirteen amendments to the agglomeration by-law concerning the internal rules and regulations for Council Meetings but that unfortunately, these recommendations were not retained.

6) <u>Irving Itman</u>:

The resident wished to apprise Council that the lights for Yitzchak Rabin Park are burned out to which Mayor Housefather responded that the Director of Public Works could look into it.

The resident then requested that the City review the by-law concerning the height of shrubs as well as the obligation to trim them for all corner properties to which Mayor Housefather responded that Councillor Levine could look into it with Urban Planning Staff.

The resident then inquired as to the legal definition of parking to which Mayor Housefather responded that in Côte Saint-Luc's By-law, it was for three minutes.

The resident then opined that the firm of Dessau Supprin who is mandated to repair Côte Saint-Luc's water infrastructure is fantastic.

The resident then wished to thank the Public Works employees for cleaning Wavell Avenue and then explained to the Public that the present Public Works Director, David Tordjman, is doing a fantastic job.

The resident then opined that he would prefer to maintain the present overnight parking regulations which do not prohibit overnight parking for less than three hours in a row to which Councillor Nashen concurred.

7) <u>Don Charness:</u>

The resident complained that one of his fellow residents is running a daycare centre out of their townhouse and that he lives in the same townhouse complex. He then inquired as to whether the City could do anything to which Mayor Housefather responded that the City could look into it but that it may be best for him to also broach the issue with his condominium association.

Councillor Cohen then explained to the resident that he will be holding a district Council Meeting on Sunday, April 23, 2006 and that the resident is welcome to bring the issue up at his meeting.

RESUMPTION OF QUESTION PERIOD

Question period resumed at 10:20 p.m. and finished at 10:35 p.m., Four (4) people asked to speak and they were heard.

1) Dr. Bernard Tonchin

The resident referred to items **5 b** and **5 c** on the Agenda and inquired as to whether the appointment of a horticulturist was pursuant to the resignation of the horticultural foreperson to which Mayor Housefather responded that while the two jobs are both in the field of horticulture, the resignation was for a non-unionized position (foreperson) whereas the position pursuant to the hiring is unionized.

The resident then explained that notwithstanding the increases in the price of crushed stone, the expense on tonight's council agenda was worthwhile.

The resident then solicited members of Council to attend agglomeration Council Meetings.

2) <u>Irving Itman</u>

The resident inquired as to whether, prior to giving a notice of motion tonight for the adoption of a demolition by-law at a subsequent meeting, there was an existing demolition by-law in Côte Saint-Luc to which Mayor Housefather responded that there was not. The resident then expressed his support for the adoption of a demolition by-law in Côte Saint-Luc.

The resident then inquired as to why there is \$60,000 being spent on shelving in the library to which Councillor Erdelyi responded that the new audio-visual room being put in, pursuant to the present library renovations, requires shelving which it does not presently have up. Councillor Erdelyi also added that any current existing shelving will be reused.

The resident then inquired as to how the dog by-law could be enforced to which Mayor Housefather responded that Public Security would be vigilant to ensure the dog by-law is respected.

The resident then called upon other residents from other reconstituted municipalities attend the Agglomeration Council Meetings to which Mayor Housefather took note and added that he could mention the resident's comment to his mayoral counterparts.

3) Alex Davis

The resident inquired as to whether the parking by-law review includes the restriction of parking large-size trucks to which Mayor Housefather responded that the by-law presently does not allow for permits to park these trucks, that the current review deals with other terms and conditions for receiving parking permits and that the review is presently being conducted by the City's ESAC committee.

4) Neal Glazer

The resident inquired regarding how any pending urban planning requests would be affected by the demolition by-law to be adopted at a subsequent council meeting to which Mayor Housefather responded that pending requests are not affected by the by-law.

The resident then inquired as to why the minor exemption regarding his home was not on tonight's Council agenda to which Councillor Levine responded that the matter must first be brought to the attention of the immediate neighbours as their comments will be taken under consideration.

The resident then inquired as to the process to have a minor exemption adopted to which Mayor Housefather responded that a request goes to the Planning Advisory Committee who issues a *recommendation* to the Council who indeed makes a final *decision*. Mayor Housefather then explained that for the resident's particular request, the matter has not been adjudicated upon by this Council.
