MINUTES OF THE SPECIAL MEETING OF THE CITY COUNCIL HELD ON TUESDAY, MAY 23, 2006 AT THE CITY HALL, 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 9:00 P.M.

QUESTION PERIOD

The question period started at 9:25 p.m. and finished at 9:47 p.m. Two (2) people asked to speak and they were heard.

1) Aubey Laufer:

The resident inquired as to whether this Special Council Meeting was published to which Mayor Housefather responded that the City has no legal obligation to publish the Meeting but that even if the City would have liked to publish the Meeting it was convened subsequent to the Suburban's publication deadline. He also added that in principle, the City tries to announce its Council Meetings on its website.

The resident then inquired as to whether there would be a second question period tonight to which Mayor Housefather responded that there would be if residents were indeed present at the end of the Meeting.

The resident then requested to defer items 11 - 20 on tonight's Council Agenda to which Mayor Housefather responded that these are indeed items which should be dealt with in a timely manner and therefore must therefore be dealt with tonight.

The resident then inquired as to who would be operating a potential snack bar and/or Café in the Eleanor London Côte Saint-Luc Public Library to which Mayor Housefather responded that currently, the City is listening to companies and individuals with proposals.

2) Avrom Shtern:

The resident inquired as to how Pavages Chenail became a sponsor of a floral contest in the City of Côte Saint-Luc to which Mayor Housefather responded that Councillor Erdelyi can look into this question and get back to the resident.

The resident then referred to a house on Baily Road near King Edward Avenue and inquired as to why the tree on the property was cut down to which Councillor Berku responded that two members of the public works staff went on site and ascertained that the tree was ill but that she is hopeful that trees will be indeed replanted on the property concerned and that the property shall be properly landscaped.

The resident then inquired regarding the particulars of the City's tree by-law to which Mayor Housefather responded that the tree by-law, as it is presently drafted, is quite rigorous.

The resident then inquired as to whether the City would be lobbying the Federal Government to convince railways and airports regarding the prohibition of the use of certain pesticides to which Mayor Housefather responded that the current voice on the matter are organizations such as the *Union des Municipalités du Québec* and the City will not get involved in any lobbying.
