

**MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON
MONDAY, DECEMBER 11, 2006, AT 5801 CAVENDISH BOULEVARD, CÔTE
SAINT-LUC, AT 8:00 P.M.**

QUESTION PERIOD

The question period started at 8:15 p.m. and finished at 9:15 p.m. Six (6) people asked to speak and they were heard.

1) Brian Ruby

The resident advised members of council that he had requested a Long-Term Overnight Parking Permit twice and both times it was rejected. He then specified that the second time it was rejected, the slope of his driveway was measured at 9.1%¹ and then questioned the accuracy of the measurement. Mayor Housefather then responded that the Urban Planning Director can personally follow up and measure a second time to which Councillor Brownstein added that he would be happy to discuss alternative parking suggestions offline with the resident.

Councillor Levine then suggested likening the calculation to a *step function* so as to state that the 9.1% was indeed 10% to which Mayor Housefather responded that the by-law does not permit such a solution.

2) Dr. Bernard Tonchin

The resident wished to rehash his suggestion from last month in which he claims that the City of Victoria allowed senior citizens to delay paying their municipal taxes.

The resident then wished to bring to council's attention an assistance programme in which residents can obtain financial assistance when their immovable's foundations are cracked when caused by pirate.

Mayor Housefather then responded that for the senior's municipal tax-related benefit awarded in Vancouver, the City clerk can research the matter and get back to him. He then took note of the resident's suggestion regarding funds available for

residents affected by pirate and mentioned that the Urban Planning Department would have more information should the resident require same.

3) Claude Hamel

The Public Works employee explained to Council that he has a tremendous respect for this council but felt that Councillor Levine's words printed in the Suburban lacked respect. He then requested that Councillor Levine draft a letter of apology to the Suburban regarding his comments and request that this letter be published in the Suburban.

Mayor Housefather first responded by stating that he has the highest amount of respect for the Public Works employees and that this year they completed all of their work well citing the cleanliness of the parks and the efficiency of the snow removal as some examples. He then added that in consideration of their good work, new tasks and responsibilities are being added such as those associated with garbage collection.

Councillor Levine then explained that he has been really happy with the quality of work that the Public Works employees have performed. He then stated that the only context in which his comments were made in the Suburban was regarding garbage collection and the only reason for his comments was that he was fearful of their safety as garbage collection for him was quite dangerous.

Councillor Brownstein thanked the employee for attending tonight and then explained to the public what a fantastic group of employees the Public Works department has. He then emphasized that council is very proud of its Public Works team and how this team has improved Public Works services throughout the City. He then explained that the Public Works team have met all of the challenges with success. He explained however that "facts speak more than words" and by awarding the Public Works staff a mandate to collect garbage in-House, the City is doing something factual that expresses pride and confidence in its public works employees.

The employee then wished to publicly thank the Public Works Director, Mr. David Torjman, ing., for the support that he has given his entire team. The employee then suggested putting a message in the newspaper wishing all of the employees a Happy Holidays.

4) Irving Itman

The resident requested that the garbage collectors ensure to put the garbage receptacles back onto the residents' lawns subsequent to emptying their garbage to which Mayor Housefather responded that since garbage collection will be done in-House, the Director of Public Works can ensure this gets followed up.

The resident inquired as to whether the budget will be merely presented or also adopted this December 18th to which Mayor Housefather responded that it will be both presented and adopted.

Mayor Housefather then proceeded to give the public a brief status report on a small projected deficit for 2006 reported in the Mayor's Report.

The resident then requested that Côte Saint-Luc join forces with other demerged municipalities to protest against the Agglomeration to which Mayor Housefather responded that he has already initiated this suggestion with his mayoral counterparts and thus far, they have not found this to be the most expedient venue to manifest their discontent with the Agglomeration.

Mayor Housefather then explained to the resident that despite the inefficiency of the Agglomeration Council, Côte Saint-Luc was still better off demerging to which the resident wholly concurred.

5) Ricky Steinberg

The resident explained to members of Council that he currently parks four vehicles in his driveway and that he has asked for a Long-Term overnight Parking Permit as in his view, it is totally impractical to move three vehicles to access the fourth one. He further expressed his discomfort with parking a vehicle overnight in public parking lots. Mayor Housefather explained that a member of Public Security can look into the resident's query and get back to him.

6) Solange Himmelfarb

The resident summarized all of her personal struggles as 'un David contre Milles Goliates' and then proceeded to describe a smell which she was convinced was a gas leak near Blossom, Guelph and Wentworth. She then called upon all members of council to refer to her as 'Franklin' as that is the name she uses when embarking upon her struggles.

Mayor Housefather explained to the resident that he, along with his colleagues on council, did receive a letter comprising several pages from her but that it only arrived immediately prior to the Council Meeting and explained that Darryl Levine, Communications Director, would undertake to respond on the City's behalf. He then explained that insofar as the alleged gas leaks were concerned, he personally followed up with the Fire Department who investigated them and found none.

**PRESENTATION TO MS. ARLETTE LÉVEILLÉ, FORMER DIRECTOR OF
PUBLIC AFFAIRS AND COMMUNICATIONS**

Mayor Housefather wished to recognize Director Arlette Léveillé's fifteen years of outstanding service with the City of Côte Saint-Luc. He explained to the public that she always did her work professionally, competently and immediately and that she was a real perfectionist. He also explained that she was a sweet, wonderful and kind person and very popular both among staff and elected officials. He along with Councillor Cohen presented her with a commemorative plaque and a lifetime Eleanor London Côte Saint-Luc Public Library membership.

**PRESENTATION TO MR. RENÉ ALLARD, FORMER COMMANDER OF POLICE
NEIGHBOURHOOD STATION 9**

Mayor Housefather explained to the public that Commander and Chief of Station 9, René Allard, will be leaving for a promotion but that during his tenure in Côte Saint-Luc, Hampstead and Montreal West he served the community well and took the time to understand and meet the three community's cultural needs. He further explained that whenever given a problem, Commander and Chief Allard always solved it well and he was a wonderful person to work with. He along with Councillors Nashen and Kovac then presented a commemorative plaque as well as a lifetime membership in the Eleanor London Côte Saint-Luc Public Library.

WHEREAS the Object of this agreement is to allow The Town of Hampstead to dump snow at the snow dump located at the intersection of Kildare Road and Marc Chagall Avenue said snow dump owned and operated by the City of Côte Saint-Luc;

The resident then called upon the City to look at a rental agreement regarding the garbage trucks, with an option to purchase to which all members of council took note.

The resident then inquired as to whether residents can receive budget documents in advance to review prior to the date the budget is adopted to which Mayor Housefather responded for next year, the City could look into the suggestion of remitting the documents in advance.

The resident then sought particulars regarding the agglomeration tax rates of this year to which Mayor Housefather responded that in the Agglomeration budget of this year Mayor Tremblay has manipulated the rates so as to unfairly bias and fiscally burden the residents of the demerged municipalities.

2) Irving Itman

The resident inquired as to whether the trucks are being rented to which Mayor Housefather responded in the affirmative.

The resident then inquired if the work approved tonight on the Cavendish Pump station was being done by Dessau Soprin to which Mayor Housefather responded that it was not.

The resident then called upon the City to develop an education programme for recycling and composting to which Mayor Housefather responded that the City could look into this suggestion. Councillor Erdelyi then specified that he, along with Councillor Berku, have already organized a citizen's committee relating to

recycling. Councillor Cohen then added that an edition of the Côte Saint-Luc Courier could potentially be dedicated to recycling.
