BY-LAW TO PROHIBIT THE DRIVING OR
OPERATING OF VEHICLES CREATING UNDUE
NOISE WITHIN THE CITY OF COTE SAINT-
LUC.

AND RESOLVED:

THAT IT BE ENACTED AND ORDAINED by a By-Law of the
City Council, and it is hereby enacted and ordained, subject to
all the approvals required by the Law, as follows:

ARTICLE 1. In this By-Law:

- a. "motor vehicle" means automobile, motorcycle or any other vehicle propelled or driven otherwise than by muscular power and used for the transportation of persons or things, but does not include the cars of electric or steam railways or other motor vehicles running upon rails.
- b. "undue noise" means any sound, the overall sound pressure level of which exceeds 94 decibels when measured at a distance of 15 feet or more from its source by use of the C-weighting scale and the "slow" setting of a sound-level meter.
- c. "sound-level meter" means an instrument which can measure noise or other sounds in decibel readings.

ARTICLE 2. No person shall drive or operate any motor vehicle that creates an undue noise within the limits of the City of Côte Saint-Luc.


ARTICLE 3. The provisions of this By-Law shall not apply to the operation of Police, Fire Department or ambulance sirens, public service vehicles, horns or bells in the course of duty or vital necessity.

ARTICLE 4. Every person who contravenes any of the provisions of this By-Law shall upon conviction thereof, pay at the discretion of the magistrate, a penalty not exceeding (exclusive of costs) \$40 for each offense.

ARTICLE 5. The present By-Law shall come into force according to Law.
