107, ENTITLED "NUISANCE BY-LAW AS

It is ordained and enacted by By-Law No. 1288 en-  
titled "BY-LAW TO FURTHER AMEND BY-LAW NO. 107 ENTITLED NUISANCE  
BY-LAW AS ALREADY AMENDED BY BY-LAW NO. 850", as follows:

By-Law No. 107, entitled "NUISANCE BY-LAW" as  
amended by By-Law 850, is hereby further amended as follows:

ARTICLE 1. Article 3 of By-Law No. 107 entitled "Nuisance By-Law" is hereby repealed and replaced by the following:

"Article 3. The throwing, depositing or piling of snow, earth, stones, mud, wood, construction debris, paper, ashes, refuse, garbage, offal, grass, flowers, bushes, leaves and other garden refuse, or any other similar matters on the street, alley, yard, public place or municipal stream, shall constitute a nuisance."

ARTICLE 2. Article 7 of said By-Law No. 107 is also repealed and replaced by the following:-


"Article 7. The use of streets and vacant lots as dumps for discarded or abandoned vehicles or trucks shall constitute a nuisance."


ARTICLE 3. The words "Article 10" in said By-Law No. 107 as amended by By-Law 850 are hereby repealed and replaced by the words "Article 10-A".

ARTICLE 4. The said By-Law No. 107 is further amended by adding thereto the following Article, namely:-

"Article 10. Any nuisance referred to in Articles 3, 5, 6 and 7 may be eliminated, abated and removed by the City, and the cost therefor form part of the costs assessed against the person responsible for or causing the nuisance."

ARTICLE 5. The present By-Law shall come into force according to Law.
