
IT IS ORDAINED AND ENACTED by By-Law No.

By-Law No. 107, entitled "NUISANCE BY-LAW"
as amended by By-Laws 850 and 1288, is hereby further
amended as follows:


ARTICLE 1. The following Article is to be added after Article 8 of By-Law 107, as follows:-

"ARTICLE 8a. The feeding of pigeons, squirrels and other wild animals and poultry shall constitute a nuisance."

ARTICLE 2. The present By-Law shall come into force according to Law.
