
IT IS ENACTED AND ORDAINED by By-Law No. 1746, ENTITLED "BY-LAW PROHIBITING CONSUMPTION OF ALCOHOLIC BEVERAGES IN PARKS", as follows:


ARTICLE 1. For the interpretation of the present By-Law, the word "Parks" shall mean all parks, playgrounds, squares, green areas, park buildings and their equipment, situated within the limits of the Cité de Côte Saint-Luc and belonging to the municipal corporation.

ARTICLE 2. No person shall carry, for purposes of consumption, or consume alcoholic beverages in City parks without the express written permission of the City Administration.

ARTICLE 3. Whosoever shall contravene any provision of this By-Law shall be liable to a fine, with or without costs, and in default of immediate payment of said fine or of the said fine and costs to imprisonment, the amount of such fine and the term of such imprisonment to be fixed at its discretion by the Court of Competent Jurisdiction in virtue of the Charter which shall hear the case, but such fine shall not exceed FIVE HUNDRED DOLLARS (\$500.00) and the term of imprisonment shall not be for a period of more than two calendar months, said imprisonment, however, to cease at any time before the expiration of the term fixed by Court upon payment of the said fine or of the said fine and cost, as the case may be.

ARTICLE 4. The present By-Law shall come into force according to Law.
