**BY-LAW CONCERNING
DOMESTIC ANIMALS**

Article 1.

Within the city limits, it is prohibited and it constitutes an offence to keep:

- (1) all marsupiala (kangaroos, opossum, etc.);
- (2) all non-human primates (monkey, chimpanzee, etc.);
- (3) all felines, except the domestic cat;
- (4) all canines, except the domestic dog;
- (5) all viverridea (civet, mongoose, etc.);
- (6) all mustelidea (weasel, otter, ermine, etc.) except the domestic ferret;
- (7) all ursidea (bear, panda, etc.);
- (8) all ungulate artiodactyla (camel, boar, etc.);
- (9) all hyenas;
- (10) all ungulate perissodactyla (rhinoceros, tapir etc.);
- (11) all elephants;
- (12) all pinnipedia (seal, walrus, sea lion, etc.);
- (13) all snakes of the python and boa family;
- (14) all poisonous reptiles;
- (15) all diurnal and nocturnal raptors (eagle, owl, etc.);
- (16) all edentate (anteater, armadillo, etc.);
- (17) all bats;
- (18) all crocodilians;
- (19) all ratite birds (ostrich, emu, etc.);
- (20) all gallinaceous (rooster, pheasant, etc.);
- (21) all pigeons, gulls, sea gulls and little wild animals such as squirrels, skunks, racoons and others.

Article 2.

Notwithstanding the provisions in Article 1, it is permitted to keep, in either one of the following places, an animal belonging to anyone of the above-mentioned categories:

- 1) A temporary exposition "petting zoo" in an area such as a shopping center;
- 2) A veterinary hospital, as long as the animal is under the care and control of a veterinarian;
- 3) An activity approved by the City of Côte Saint-Luc.

Article 3.

Authority entrusted to apply by-law

The SPVM, the City of Côte Saint-Luc's Public Security Department and any competent authority designated on the territory of the city to have control over properties and public places of the city and are entrusted to uphold this by-law. They are therefore authorized to take any measures related to their expertise to insure the respect of this by-law.

They are, amongst other things, authorized to visit and examine inside and outside any immovable or movable property, to verify if this by-law is respected.

Article 3.

Infraction and Penalty

Anyone contravening to one of the following sections, commits an infraction and is liable, besides the costs, to a minimum and maximum fine as indicated hereafter:

For a natural person; the minimum fine is \$100 and the maximum fine is \$1,000, plus the costs as stipulated in the Code of Penal Procedure. For any subsequent offence (as defined in the Code of Penal Procedure), the minimum fine and the maximum fine are both doubled.

For a moral person (Company); the minimum fine is \$200 and the maximum fine is \$2,000, plus the costs as stipulated in the Code of Penal Procedure. For any subsequent offence (as defined in the Code of Penal Procedure) the minimum fine and the maximum fine are both doubled.

Article 4.

This by-law comes into force on according to the law.
