MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL HELD ON MONDAY, MAY 14, 2007, AT 5801 CAVENDISH BOULEVARD, CÔTE SAINT-LUC, AT 8:00 P.M.

PRESENTATION TO ABE SIMKIN IN RECOGNITION OF YEARS OF DEDICATION TO THE CÔTE SAINT-LUC GARDEN CLUB

A presentation was made to Abe Simkin in recognition of his years of dedication to the Garden Club. Subsequent to the presentation, a commemorative photo was taken.

QUESTION PERIOD

The question period started at 8:03 p.m. and finished at 9:06 p.m. Eight (8) people asked to speak and they were heard.

1) <u>Carl Abramovitch</u>

The resident inquired as to why he can no longer walk his dog in an area on Marc Chagall in which he was previously able to do so to which Councillor Cohen responded that after the Urban Planning Department researched the area in question, they found that it was designated a park. Mayor Housefather then explained that Côte Saint-Luc has a long-standing by-law concerning dogs which prohibits dogs from being in city parks.

The resident then explained that it was helpful to have dog clean-up materials provided by the City on various parts of its territory to which Mayor Housefather responded that the City can look at possibly providing more of these materials where dogs are permitted to be walked.

2) Avrom Shtern

The resident wished to thank Côte Saint-Luc's city council for commemorating VE Day in such a grand manner.

The resident then opined that Irving Layton's former house in Côte Saint-Luc should be declared a historical site.

The resident then inquired as to whether the City was presently in discussions with Borough of Lachine Mayor Claude Dauphin concerning Meadowbrook to which Mayor Housefather responded that the City has been indeed in contact with Mayor Dauphin – but on other matters – and should discussions be expedient regarding Meadowbrook, the City will pursue them.

3) <u>Louis Westernoff</u>

The resident explained to council that he witnessed someone exhibiting inappropriate behaviour on his street but when he called Public Security, they never responded. Mayor Housefather clarified for the resident that the behaviour described tonight should be dealt with by the police¹ in principle and to which Councillor Nashen added that Public Security was particularly inundated with calls during the month of April and may very well have already been called on scene to another problem. Mayor Housefather then stated that nonetheless, the City could look into why noone responded and someone from the City would get back to the resident.

4) Catherine Nemeth

The resident tabled a petition signed by her fellow residents calling upon the City to ban barbecuing. She then further expressed her support for the petitioners' request. Mayor Housefather then explained to the resident that in addition to the City's by-laws, her condo association could also enact by-laws prohibiting barbecuing.

Councillor Nashen then explained to the resident that Côte Saint-Luc was a leader going back over forty years regarding its current by-law concerning barbecuing realizing back then that there were safety issues.

Mayor Housefather then explained that the City is not purporting to make its by-law concerning barbecues more lenient or severe but rather looking into ensuring that it is commensurate with current provincial and federal norms which also govern barbecue use.

5) Jack Cabot

The resident complained that he can no longer speak with Public Works directly when he has a complaint for which Mayor Housefather clarified that, to better serve the resident, the City allows the resident to file a complaint directly with someone at its reception so the resident does not have to get bounced around from department to department. He then further clarified that should the resident wish nonetheless to speak with Public Works directly, they are still free to do so.

The resident registered his objection to the building project on Robert Burns Avenue and Côte Saint-Luc Road.

The resident then requested that the traffic light at the corner of Ashdale Avenue and Côte Saint-Luc Road be adjusted so that there be an easier and a safer way for motorists to turn left onto Côte Saint-Luc Road to which Mayor Housefather responded that the traffic light is not within the City's territory but someone from the City can advise the neighbouring borough of the resident's suggestion.

6) Steven Segal

The resident complained of motorists speeding on Marc Chagall Avenue to which Mayor Housefather responded that the City's traffic committee can further look into this and see if any other practical solutions can be implemented.

The resident then requested to be able to barbecue and called upon this council not to have a by-law which prohibits him to do so to which Mayor Housefather responded that the City is presently looking into what legislative changes occurred in provincial and federal norms dealing with barbecuing and once reviewing these changes, it will then decide whether or not it needs to amend its current by-law to reflect them.

Councillor Nashen then explained to the public that he is particularly concerned with public safety and cited examples of barbecue fires which occurred in the City which necessitate having by-laws regulating barbecues. He then further explained that he was instrumental in enacting a by-law compelling homeowners to have sprinklers in their homes which, once again, promotes and preserves public safety. He further explained that when Côte Saint-Luc demerged, it was able to enact excellent, high-level by-laws.

7) <u>Jay Kazenel</u>

The resident requested to be able to barbecue to which Mayor Housefather responded that the last thing the City wishes to do is deprive people of the enjoyment of their property but in certain instances, when it isn't safe, the by-law concerning barbecues must be enforced.

The resident then inquired as to whether he can be advised the next time the issue concerning barbecues is discussed on a council agenda to which Mayor Housefather responded that the resident should leave his name and e-mail address to be on the City's distribution list.

Councillor Cohen then explained that the City will be surveying its condominium owners to see as to whether the condominiums within its territory already have their own by-laws concerning barbecuing.

8) <u>Sidney Morris</u>

The resident requested that the City advise him as to the approximate time during the day that his garbage will be picked up to which Mayor Housefather responded that the City can indeed follow up on his request.

BUSINESS ARISING FROM THE MINUTES

Councillor Berku explained to the public that she is presently working on an amendment to the articles in the City's Zoning by-law concerning trees and what she has found thus far is that every reconstituted municipality have articles in their by-laws protecting private trees. She further explained that Côte Saint-Luc has faced a tree deficit over the past few years. She further explained that Côte Saint-Luc's Citizens on Patrol are being vigilant regarding individuals who are illegally cutting down trees. She then called upon the City to protect its private trees as she explained that, "a tree is a tree is a tree." She then explained that, "in this day and age, trees are essential" and then welcomed the public to get involved in the discussion. She then urged council to support a comprehensive tree by-law.

Councillor Levine then expressed his support for Councillor Berku's comments explaining that the value of a home is based on the mature trees in its surrounding areas. He then explained that trees, by creating shade, may cool a home in the

summertime. He further explained that trees enhance the quality of life of the individual and that the City should do what it can to protect its trees.

WHEREAS according to section 4 of *An Act respecting the exercise of certain municipal powers in certain urban agglomerations* (R.S.Q., c. E-20.001), the urban agglomeration of Montreal is made up namely of the City of Côte Saint-Luc since January 1, 2006;

WHEREAS according to section 58 of *An Act respecting the exercise of certain municipal powers in certain urban agglomerations* (R.S.Q., c. E-20.001) (hereinafter "the Act"), every central municipality has an urban agglomeration council, the nature, composition and operating rules of which are set out in an order in council and that this agglomeration council constitutes a deliberative body of the municipality;

WHEREAS under section 59 of the Act, every municipality must be represented on the urban agglomeration council;

WHEREAS according to section 61 of the Act, at a meeting of the council of a related municipality, the mayor informs the council of the matters that are to be considered at a future meeting of the urban agglomeration council, sets out the position the mayor intends to take on any matter referred to at the urban agglomeration council meeting, discusses that position with the other members present and proposes the adoption of a resolution establishing the council's stance;

WHEREAS an agglomeration council meeting shall be held on May 31, 2007 for which members of the municipal council shall establish the stance that it wishes to take;

The resident then inquired as to whether notices of infraction are being issued for residents who put out their garbage outside of the hours permitted to do so to which Councillor Nashen responded that Public Security does indeed follow up to see if resident's are respecting Côte Saint-Luc's by-laws including the one concerning garbage collection hours.

2) Jack Cabot

The resident inquired as to the nature of the signs to be erected on Côte Saint-Luc's territory regarding the obligation for motorists to stop for pedestrians to which Councillor Nashen responded.

The resident then opined that there is a need for a crosswalk at Saint-Patrick's Square for which Mayor Housefather clarified that the area in question is not completely within Côte Saint-Luc's jurisdiction and therefore Côte Saint-Luc cannot unilaterally modify the traffic configuration at that corner.

The resident then inquired as to why the desktop computers purchased tonight were purchased without monitors for which City Manager Lerner responded that the City already has perfectly functioning monitors to accompany tonight's purchased computers.

The resident then sought particulars regarding the loan by-law adopted tonight to purchase computer equipment to which both Mayor Housefather and City Manager Lerner responded.

The resident then inquired as to the nature and location of the Servitude adopted on tonight's council agenda to which Mayor Housefather responded.

3) <u>Avrom Shtern</u>

The resident wished to personally thank and congratulate Councillors Berku, Nashen and Levine for, 'standing up for trees.'

The resident then registered his objection regarding his fellow residents having swimming pools as he opined that there is a present water shortage and swimming pools necessitate the use of a significant amount of water.
