QUESTION PERIOD

The question period started at 8:10 p.m. and finished at 8:35 p.m. five (5) people asked to speak and they were heard.

1) Dr Bernard Tonchin

The resident inquired if there were provincial laws that apply to the handling of metro cars. Mayor Brownstein mentioned that this is not a municipal competence and then differed the question to Mrs. Elizabeth Prass, a duly authorized representative of National Assembly member David Birnbaum. Mrs. Prass clarified that the STM is responsible for the management of metro cars and the provincial government is responsible for the purchasing of metro cars and the handling of their contractual bids.

2) Irving Itman

The resident asked for the most recent statistics for tempos in the City. Councillor Erdelyi mentioned that as of January 31, 2019, 114 tempo permits were issued; which is an increase from the 98 permits that were issued as of December 31, 2018.

The resident then inquired if there were any developments with regards to the legislation concerning cannabis in the City. Mayor Brownstein explained that, at this time, the City is looking into enacting (a definition in) the same by-law that applies to smoking tobacco to also apply to the consumption of cannabis and that council is still debating the question.

The resident then inquired about the City's *concrete* plans for its traffic-congested road system given the continued traffic congestion on Decarie. Mayor Brownstein then mentioned that he received a letter from Valérie Plante, Mayor of Montreal, indicating that there would be a meeting on February 14, 2019 to discuss the topic.

3) Mike D'Alessandro

The resident inquired about the lights on Trinity Avenue that have been off for more than a month due to damages to a lamp post. Mayor Brownstein and Councillor Tordjman both mentioned that they were not aware of the situation but they are taking note of it so that staff can follow up.

The resident also inquired about the removal of a large container¹ on Trinity Avenue. Mayor Brownstein mentioned that he will have the Director of Public Works ensure the resident was contacted.

4) Ariel Abitbol

The resident mentioned that he recently moved to Côte Saint-Luc and he suffered a sewer back-up in his basement due to a crack in the main drain. He mentioned that in neighbouring cities the repair costs for such situations are covered by the City, but he was told this is not the case in Côte Saint-Luc. Councillor Kujavsky differed the question to Me Jonathan Shecter, Co-City Manager, and he stated (under reserve of a proper review of the insurance policy) that insurance companies may pay for the damages (from a "sinistre") but would not, usually, as a general rule, pay to repair the "cause" of the damages. Me Shecter also suggested that the resident should consult his insurance company to see if the excavation fees were part of his insurance coverage.

5) Tamar Hertz

The resident inquired about the City providing financial support to organizations or clubs, such as the Côte Saint-Luc Men's Club, using City facilities at no cost while excluding certain female residents from Men's Club activities. Mayor Brownstein explained that every organization has its own independent set of rules, but that the City will see what it can do in acting as mediators. He then added that the numerous services provided to residents by these organizations alleviate the City from providing them and the community, at large, benefits from them.

WHEREAS agglomeration council meetings may be held in March 2019 for which members of the municipal council shall establish the stance that it wishes to take;

WHEREAS the Coalition Avenir Québec is currently proposing flawed and unconstitutional legislation which, according to their owned publicity is as follows:

"Religious signs will be prohibited for all persons in position of authority, including teachers."

WHEREAS their proposed flawed and unconstitutional legislation in predicated in their following logic:

"After 20 years of discussion on the subject and on reasonable accommodations, it is more than time to act and adopt legislation clearly establishing the secularity of the state."

WHEREAS in the opinion of the Côte Saint-Luc City Council, the proposed legislation infringes rights granted under the Canadian Charter of Rights and Freedoms and the Quebec Charter of Rights in a way that is not reasonable in a free and democratic society;

WHEREAS the Côte Saint-Luc City Council believes that the state can be secular while still supporting all religions and those who have no religion and that the way an individual is dressed as a result of their religious beliefs in no way impacts such individuals' ability to provide either unbiased opinions or services in a secular state;

WHEREAS the proposed Charter will make our civil service, less diverse, as the law forbids employees such as: police, fire, and security forces and judges from wearing religious attire even when such attire is required as a result of their religious beliefs;

WHEREAS the City of Côte Saint Luc is composed of people of many cultures, languages and religions, and has no difficulty supporting all such cultures, languages and religions and has no difficulty with civil servants (whether or not they are considered *persons in authority*) who wear religious head-coverings and/or religious symbols;

WHEREAS not one of the residents of our city has ever complained about the clothes/jewelry worn by our civil servants wearing religious attire;

WHEREAS our city wants to have diversity not only in its own local civil service but the Federal, Provincial and (municipal)-Agglomeration-wide civil services as well;

SECOND QUESTION PERIOD

The second question period started at 9:01 p.m. and finished at 9:10 p.m. three (3) people asked to speak and they were heard.

1) Shoshana Moscovitz

The resident addressed the coucil about the crosswalk in front of her residence situated at 6700 l'Avenue which she considers very dangerous. Mayor Brownstein responded that the City would look into making the crosswalk more visible. Tanya Abramovitch, City Manager, also mentioned that traffic-calming measures are installed in the summer, such as big plants in the street and that the City is also looking into installing year-round traffic-calming measures.

The resident also mentioned that there is no parking on the street in front of her residence due to the significant activity at and around the Cavendish Mall. Mayor Brownstein then mentioned that there is parking behind her residence and that out of town family members can also request overnight parking permits for the street. He did, however, mention that the City would look into the matter further.

2) Irving Itman

The resident asked if there was a City by-law to enforce the installation of carbon monoxide detectors in homes. Mayor Brownstein explained that there is no such by-law but it is being discussed. The resident strongly suggested that it should be included in a City by-law.

The resident then inquired about the financial impact of a Fixed-Term employment contract versus a permanent employment contract. Mayor Brownstein mentioned that a one year Fixed-Term contract is the probationary period before making the contract permanent and that there is no budgetary impact when an employee's status changes.

The resident then inquired about the status of the second public consultation related to the upgrades to Kirwan Park. Mayor Brownstein indicated that there will be a second public consultation after the tender process is concluded.

3) Dr Bernard Tonchin

The resident complained that it is difficult to hear what is being said during Council meetings because those who have microphones to help amplify their voices forget to use them. All members of Council took note of the resident's comment.
